

Summary:

Robyn Slater reported that the current Labor Agreements with UTU, Local 23, Fixed Route and Paratransit, each include language that specifies the amount METRO will contribute towards medical premiums. The Fixed Route resolution is adjusted annually to reflect actual maximum monthly premium contributions and the Paratransit resolution corrects an error in the original resolution established in 2004.

8. <u>CONSIDERATION OF REVIEWING, REVISING, AND PRIORITIZING THE LIST OF</u> <u>UNMET TRANSIT AND PARATRANSIT NEEDS TO BE CIRCULATED TO THE</u> <u>ELDERLY & DISABLED TRANSPORTATION ADVISORY COMMITTEE (E&D TAC) AND</u> <u>THE METRO ADVISORY COMMITTEE (MAC)</u>

Summary:

Chair Tavantzis explained that the Board was being asked to review and prioritize METRO's draft list of Unmet Transit and Paratransit needs. The Board reviewed the SCCRTC's list first to determine if METRO agrees with the prioritization. The Board modified the priority of several items.

Discussion:

Director Hagen created another version of METRO's list and assigned each with a priority of VH-Very High need, H- High need, M- Moderate need and L- Low need, which was distributed to the Board and is attached to the file copy of these minutes. The Board reviewed each item and assigned all items regarding maintaining current service Very High need, all items related to improving existing service a High need, and the remainder were assigned Moderate and Low need. Two items were removed from the list completely. The Board decided to eliminate the numbers indicating in which order items should be listed, instead giving each item only a priority ranking, with all items in each category being of equal priority.

Les White reported that he would recreate Director Hagen's list indicating the priority ranking of each item as assigned by the Board today, including a brief summary of how the Board arrived at each category of priority. The list would then come back to the Board in two weeks, along with MAC and E&D TAC's input and a Public Hearing would be held at that time. After receiving input, the Board would then finalize the list to be submitted to the SCCRTC.

The Board requested a matrix of the listed items if MAC and E&D TAC's opinions differed widely from the Board's.

Summary:

Robyn Slater reported that the Fixed Route resolution is adjusted annually to reflect METRO's actual maximum monthly premium contributions and the Paratransit resolution corrects an error in the language provided by CalPERS in the original resolution established in 2004.

ACTION: MOTION: DIRECTOR ROTKIN SECOND: DIRECTOR REILLY

Approve the Resolutions to revise the fixed contribution towards medical coverage for the United Transportation Union, Local 23 (Fixed Route) and Paratransit Unit under the California Public Employees' Retirement System (CalPERS) medical insurance program

Motion passed unanimously with all Directors present.

8. <u>PUBLIC HEARING: CONSIDERATION OF IDENTIFYING A PRELIMINARY LIST OF</u> UNMET TRANSIT AND PARATRANSIT NEEDS FOR SUBMISSION TO THE SCCRTC

Summary:

Les White reported that at its last meeting, the Board reviewed, revised and assigned priority ranking to METRO's draft list of Unmet Transit and Paratransit needs. The list was transmitted to E&D TAC for their consideration; however, they did not meet as scheduled on August 14th and they have provided no feedback. MAC reviewed the list at their August 15th meeting and their comments are included as Attachment "C". After receiving public comment at today's Public Hearing and reviewing all input received, it is recommended that the Board adopt a final list of Unmet Transit and Paratransit needs to be submitted to the SCCRTC.

Discussion:

Director Rotkin asked for clarification on how important it was to prioritize each item on the list, in light of the current state budget crisis. Les White replied that this is the first time that the SCCRTC has requested prioritization of the list and staff believes it is a constructive exercise to determine METRO's priorities in case extra funds should somehow materialize, however it is not a binding prioritization.

Director Hagen expressed concern that E&D TAC did not comment on METRO's list.

CHAIR TAVANTZIS OPENED THE PUBLIC HEARING AT 9:13 A.M.

Bob Yount, MAC, reported that MAC took this seriously and had spent a lot of time on it. MAC recommends that the criteria of impact on the highest number of riders be used when implementing service improvements. Mr. Yount stated that one area where MAC disagreed with the Board was on Holiday Service, which MAC feels strongly should be changed from low priority to high priority. Mr. Yount went on to comment on each of MAC's recommendations that differed from the Board's.

There was a discussion about Holiday Service.

CHAIR TAVANTZIS CLOSED THE PUBLIC HEARING AT 9:21 A.M.

Chair Tavantzis explained that when the Board reviewed and prioritized the list that system-wide items were high priority, route-specific items were lower priority, etc.

Director Spence requested a cost breakdown. Chair Tavantzis replied that the items were not prioritized by cost, which is not a factor at this point. Les White clarified that there is no funding to implement any of the items, however, staff would be happy to determine costs when and if funding became available. Director Stone added that this was a worthwhile effort and thanked staff and MAC for their time spent on it.

Vice Chair Beautz asked about MAC's recommendation to add the replacement of 30 1998 fixed route buses to the list as a very high priority. Les White agreed that would be a good idea and the maker and second of the motion accepted the following amendment:

Director Reilly thanked Director Spence and MAC, stating it was good to have MAC's input even though all of their recommendations were not being incorporated at this time.




# 3. ORAL/WRITTEN COMMUNICATION

<u>Oral</u>: Chair Robert Yount stated that he was looking forward to the joint meeting with MAC and the METRO Board of Directors but did not know the time and date of the meeting at this time.

# 4. CONSIDERATION OF MINUTES OF JUNE 20, 2007

Stuart Rosenstein made the following corrections to ITEM 3 Oral/Written Communication, third paragraph should read, "<u>Oral:</u> Stuart Rosenstein expressed his <u>an occasional</u> dissatisfaction with Yellow Cab Company of Santa Cruz <u>as a source of transportation</u>. Mr. Rosenstein said that <u>drivers have <u>dispatch has</u> been indifferent and uncaring, while management has been unresponsive and hard to get a hold of."¹</u>

Vice Chair Paul Marcelin-Sampson made the following correction: On pages 1, 2, and 4, the correct spelling for Karenna Pushnik's name should be **Karena** Pushnik.²

Motion passed unanimously with Dan Alper, Dave Williams and Lesley Wright being absent.

# 5. RIDERSHIP REPORT FOR MAY 2007

Chair Robert Yount referred to an amended Ridership Report that was handed out at the meeting, which is attached to the file copy of these minutes, and reported that it contained additional information requested by MAC. Vice Chair Paul Marcelin-Sampson asked if the METRO Board of Directors would also see the amended Ridership Report. Les White stated that if MAC felt the report was satisfactory then it would be presented to the Board of Directors.

Mara Murphy stated that the amended report appears to have conflicting data than that of the original report from the Agenda packet, specifically in the totals of the ECO Pass column of Route 17, the totals for the Night Owl, and the totals of the May Ridership/Revenue table. Naomi Gunther asked if there were known reasons for the variations between the reports. Vice Chair Paul Marcelin-Sampson suggested that an asterisk be added to the Route 17 stating that the fare for this route is higher than the regular fixed routes for data interpretation purposes. Mr. Marcelin-Sampson stated that there could be a variety of reasons why the report might contain incorrect or conflicting data but that it would probably be easily corrected for future reports.


# 6. PARACRUZ OPERATIONS STATUS REPORT FOR MARCH 2007

Chair Robert Yount referred to the "ready-window" table on page 2 of the report and commented that the percentages of pick-ups outside the ready-window beyond 15 minutes shows an improvement and feels that overall the ParaCruz service is constantly improving.

Vice Chair Paul Marcelin-Sampson expressed some concern that the cancellation rate has remained fairly constant and asked if the reduction from 14 days to 3 days of the ParaCruz reservation policy has gone into effect and if it has shown any significant change in cancellations. Ciro Aguirre reported that the policy change went into effect in April of 2007 and would not show a change on this report. Mr. Aguirre stated that he had talked to Steve Paulson and that Mr. Paulson had informed him that the number of cancellations has been dropping since the policy change has been in effect.

# 7. DISCUSSION OF USAGE RULES FOR PARK & RIDE FACILITIES

Chair Robert Yount stated that he had heard that the California Highway Patrol (CHP) has been informing tow truck operators to take automobiles to the Park & Ride facilities. Ciro Aguirre stated he had heard that the CHP had made these instructions to tow truck drivers



when removing disabled vehicles from the highway. Les White stated that he would need to research this issue further prior to making any comment.

Mr. White reported that the METRO is aware of privately owned companies that are parking several of their vehicles in the Scotts Valley Park & Ride location. Mr. White explained the situation and stated that the METRO and the City of Scotts Valley are exploring options to resolve the situation.

Vice Chair Paul Marcelin-Sampson asked who governs the Park & Ride facilities and if there was a policy regarding usage rules of the facilities. Les White reported that the METRO does not have a policy on the two Park & Ride facilities that are owned by the METRO because there have not been these types of issues in the past. Mr. White gave a brief history of the METRO Park & Ride facilities and described some of the possible changes that could occur in the future.

### 8. <u>DISCUSSION OF METRO BOARD OF DIRECTORS ACTIONS REGARDING MAC</u> <u>RECOMMENDATIONS</u>

Les White reported that the METRO Board of Directors has adopted the majority of the MAC recommendations made in the past several months including absence notification procedure, quorum modifications, and passes for MAC Members that attend meetings.

Les White reported that the METRO Board of Directors requested clarification of the definitions of "excused" and "unexcused" absences from the MAC Bylaws Absentee Policy.

Chair Robert Yount stated that he would like to add two items to the August MAC Agenda for discussion: 1. Defining Absentee Policy, 2. Conflict of Interest for MAC Membership. Margaret Gallagher stated that she would write a legal opinion to discover the definitions of MAC Bylaws Conflict of Interest issues as compared to the METRO Board of Directors Bylaws.

#### 9. <u>CONSIDERATION OF LIST OF UNMET TRANSIT NEEDS FOR SUBMISSION TO</u> <u>SCCRTC</u>

Chair Robert Yount introduced 2 hand-outs from Les White to MAC: "Draft List of Unmet Specialized Transportation/Transit Needs, June 2007" from the Elderly and Disabled Transportation Advisory Committee (E&D TAC) and "Draft 2007 Unmet Needs – METRO" from SCMTD, which are attached to the file copy of these minutes.

Les White explained the meaning and purpose of Unmet Needs and the development of the lists. Mr. White stated he had provided the "Draft 2007 Unmet Needs – METRO" for MAC to review and make suggestions for additions and/or deletions from the list at the August MAC Meeting. Mr. White described the routing process and time line for the list.

Les White described in detail various aspects of governmental funding including the proposed FY 2008 State of California budget and the effects they may have on public transit and METRO.



### I. RECOMMENDED ACTION

#### II. SUMMARY OF ISSUES

- METRO ParaCruz is the federally mandated ADA complementary paratransit program of the Transit District, providing shared ride, door-to-door demand-response transportation to customers certified as having disabilities that prevent them from independently using the fixed route bus.
- METRO assumed direct operation of paratransit services November 1, 2004.
- Operating Statistics and customer feedback information reported are for the month of June 2007.
- A breakdown of pick-up times beyond the ready window is included.

#### **III. DISCUSSION**

METRO ParaCruz is the federally mandated ADA complementary paratransit program of the Transit District, providing shared ride, door-to-door demand-response transportation to customers certified as having disabilities that prevent them from independently using the fixed route bus.

METRO began direct operation of ADA paratransit service (METRO ParaCruz) beginning November 1, 2004. This service had been delivered under contract since 1992.

There has been discussion regarding ParaCruz on-time performance. It was noted that most statistical data continues to show improvement, the reported percentage of pick ups performed within the "ready window" has remained relatively consistent, hovering at roughly 90%. Staff was requested to provide a break down the pick-ups beyond the "ready window".

Arntz Builders will be going through a punch-list to finalize building and have been working on them as items come up.

AT&T has been onsite multiple times to complete their work for the telephone lines for the facility. These lines will be used for the Fire Monitoring System, Card Reader, and LNG Monitoring.

West Bay Builders is continuing site work on 120 Golf Club Drive property. The tilt-up framework has been placed, and the panels have been poured. After 7 day curing occurs, the panels will be installed. West Bay Builders will be using a crane to lift the panels and place them on their corresponding locations on the building layout. Other work occurring on the site is the site work for PG&E transformer. PG&E will be providing cut sheets and drawings for the transformer and platform that will be placed on the Vernon side area.

SUBJECT: CONSIDERATION OF APPROVING A RESOLUTION TERMINATING THE CALIFORNIA PUBLIC ENTITY INSURANCE AUTHORITY (CPEIA) JOINT POWERS AGREEMENT

#### I. RECOMMENDED ACTION

## Approve the Resolution Terminating the California Public Entity Insurance Authority Joint Powers Agreement (CPEIA)

#### II. SUMMARY OF ISSUES

- The Santa Cruz Metropolitan Transit District (METRO) has been a member of CPEIA joint powers agreement in order to access excess workers' compensation insurance.
- METRO no longer has a need to be a member of the CPEIA as it is now allowed to be a participating member of the California State Association of Counties (CSAC) which provides for access to various insurance coverages including excess workers' compensation insurance.
- CSAC Excess Insurance Authority (EIA) has requested that METRO execute the attached resolution to document its action to terminate the CPEIA as soon as possible but at least before December 31, 2007.

#### III. DISCUSSION

The Santa Cruz Metropolitan Transit District (METRO) has been a participating member of the CPEIA joint powers agreement in order to access excess workers' compensation insurance. CPEIA was created by the California State Association of Counties (CSAC) as a "sister JPA" to provide other public agencies with the opportunity to participate in CSAC's programs and services, specifically insurance programs including excess workers' compensation insurance coverage. On February 28, 2006, the County Supervisors Association of California dba CSAC Excess Insurance Authority (EIA) Joint Powers Agreement was amended to allow all public entity members to join the CSAC EIA directly. The transition of the CPEIA members into the CSAC EIA has been in progress for the past year and a half. As of June 30, 2007, all CPEIA members executed the appropriate documents to join the CSAC EIA directly, including METRO. Along with membership rights, public entity members will also be granted limited voting rights on the Board of Directors and the Executive Board. The last phase of the transition plan is the termination of the CPEIA as an entity.

At its meeting on May 29, 2007, the CPEIA Board of Directors took action to terminate the contractual agreement between the CSAC EIA and the CPEIA effective July 1, 2007. Now the CPEIA members, acting through their governing boards, must take action to terminate the CPEIA Joint Powers Agreement.

According to the CPEIA Joint Powers Agreement, the CPEIA will be officially terminated upon approval by three-fourths of the CPEIA members acting through their governing bodies. With 134 CPEIA members, approval of 101 governing boards to effect the termination.

CSAC EIA has requested that METRO execute the attached resolution to document its action to terminate the CPEIA as soon as possible and before December 31, 2007.

#### IV. FINANCIAL CONSIDERATIONS

None, the CPEIA has no assets to distribute and no programs of the CPEIA were ever established.



- SUBJECT: CONSIDERATION OF AUTHORIZING THE GENERAL MANAGER TO EXECUTE AN ASSIGNMENT OF THE LEASE AGREEMENT OF THE CHINESE RESTAURANT AT THE WATSONVILLE TRANSIT CENTER TO YU NING HE AND ELAINE WANG, SUBJECT TO ALL RENTS, OBLIGATIONS, INTEREST AND LATE CHARGES BEING PAID TO METRO

#### **ACTION REQUESTED AT THE SEPTEMBER 14, 2007 BOARD MEETING**

#### I. RECOMMENDED ACTION

Authorize the General Manager to execute an Assignment of the Lease Agreement of the Chinese Restaurant, previously Delicious Fast Foods, to Yu Nine He and Elaine Wang while retaining all former tenants as obligors on the lease, subject to all rents, obligations, interest and late charges being paid to METRO.

#### II. SUMMARY OF ISSUES

- The Board of Directors authorized a five-year Lease Agreement between Santa Cruz METRO and Mr. Gharahgozloo and Ms. Hsu for the restaurant space at the Watsonville Transit Center, which became effective September 1, 2003. They operated an Asian food restaurant until September 1, 2005, dba Jessica's China Express.
- On August 26, 2005 the Board of Directors approved a lease assignment of Jessica's China Express Lease to the new tenants, Feng Ju Gao and Chun Yin, dba China Wok Express.
- Ms. Gao and Mr. Yin had difficulty making a go of the new business. They lived in San Jose and found the commute difficult.
- On February 24, 2006 the Board of Directors approved a lease assignment of China Wok Express to new tenants, Po Zhao and Aiping Zhang, dba China Station Express.
- On May 26, 2006 the Board of Directors approved a lease assignment of China Station Express to new tenants, Minh Vo and Trang Tran, dba Delicious Fast Food.
- Mr. Vo and Mr. Trang have been unable to make the business prosper and have defaulted on the Lease Agreement and left the premises closed for the last 6+ months.
- Po Zhao and Aiping Zhang have found new buyers/assignees for the business and are requesting METRO approve the new tenants in a new Lease Assignment.



#### III. DISCUSSION

Mr. Gharahgozloo and Ms. Hsu entered into a Lease Agreement for the Watsonville Transit Center main terminal restaurant space in July 2003 for a new Asian restaurant. The lease agreement included approximately 811 square feet of restaurant space in the terminal building and kiosk #8, approximately 220 square feet of space used for storage purposes. After remodeling, their Lease began on September 1, 2003 and included a five-year initial term with an option for an additional 5-year extension period.

On August 26, 2005, the Board of Directors approved the request of Mr. Gharahgozloo and Ms. Hsu to assign their lease to Feng Ju Gao and Chun Yin. The new owners opened a new restaurant, selling Chinese and American food, dba China Wok Express. The new Lease began on September 1, 2005.

Although both tenants were working as cooks at separate Chinese food restaurants and both claimed to have extensive restaurant experience, they had a difficult time succeeding in the business. They lived in San Jose and found the commute difficult.

On February 24, 2006, the Board of Directors approved the request of Feng Ju Gao and Chun Yin to assign their lease to Po Zhao and Aiping Zhang, dba China Station Express.

On May 26, 2006 the Board of Directors approved the request of Po Zhao and Aiping Zhang to assign their lease to Minh Vo and Trang Tran, dba Delicious Fast Foods. However, Delicious Fast Foods could not sustain itself financially and the owners have filed for bankruptcy. As Mr. Vo and Mr. Tran defaulted on the agreement, Po Zhao and Aiping Zhang have found new buyers/assignees for the business.

The Property and Leasing Committee has reviewed the proposed tenant's financial information, the Purchase and Sale Agreement and a copy of the revised Lease Assignment, which if executed, is conditional pending close of escrow for the sale of the business. All monies owed on the lease, currently approximately \$15k will be paid in full upon the close of escrow on the sale of the business. METRO's Finance Manager, Angela Aitken has reviewed all the financial information for the proposed new tenant and because METRO is being made whole, is recommending this Lease Assignment.

#### IV. FINANCIAL CONSIDERATIONS

Rent for the space is currently \$1,352.52 per month, or \$16,230.24 annually. The sale of the business is contingent on the requirement that the outstanding monies owed by tenants to METRO, will be paid in full out of the escrow, currently \$16,498.92.

#### ASSIGNMENT OF THE SANTA CRUZ METROPOLITAN TRANSIT DISTRICT – WATSONVILLE TRANSIT CENTER LEASE DATED SEPTEMBER 1, 2003

THIS IS AN ASSIGNMENT of lease by and among Santa Cruz Metropolitan Transit District ("Landlord"), Ali Gharahgozloo and Jessica Hsu, ("Tenants"), Feng Ju Gao and Chun Yin, ("Tenants"), Po Zhao and Aiping Zhang ("Tenants") and Yu Ning He ("Assignee").

For good consideration, it is agreed by and among the parties that:

- 1. The Tenants hereby assign, transfer and deliver to the Assignee all of the Tenants' rights in and to a certain lease between the Tenants and the Landlord for certain premises which consist generally of approximately 811 Square feet of restaurant space in the terminal building and Kiosk #8, a 220 square foot kiosk, including one roll up door located at 475 Rodriguez Street, Watsonville, California under a lease dated September 1, 2003, as amended (the "Lease"). A copy of the Lease and applicable amendments are attached hereto as Exhibit A and made a part hereof by reference.
- 2. The Assignee agrees to accept the said Lease, to pay all rents and punctually perform all of the Tenants' obligations under the said Lease accruing on and after the date of delivery of possession to the Assignee as contained herein. The Assignee further agrees to indemnify and save harmless the Tenants from any breach of the Assignee's obligations hereunder.
- 3. The parties acknowledge that the Tenants shall deliver possession of the leased premises to the Assignee on or after October 1, 2007, and that time is of the essence. All rents and other charges accrued under the Lease prior to said date shall be fully paid by the Tenants, and thereafter by the Assignee.
- 4. Furthermore, Assignee shall reimburse Tenants for the amount of the Security Deposit upon signing this Agreement. If Assignee does not fulfill any of its obligations under the Lease, Landlord may apply the Security Deposit on account of such obligation or to reimburse Landlord for any sum that Landlord may expend due to Tenants' or Assignee's default. If Landlord applies any part of the Security Deposit, Assignee (and Tenants upon failure of Assignee), immediately after notice from Landlord, shall deposit with Landlord the amount so applied so that Landlord shall have the full Security Deposit available at all times during the term of the lease.
- 5. The Landlord hereby consents to the assignment of lease, provided that:
  - a) Consent to the assignment shall not discharge the Tenants of its obligations under the Lease in the event of the breach of same by the Assignee.

- b) All monies due and owing to Landlord by Tenants and previous Assignees are paid in full at the time of Assignment.
- b) In the event of breach by the Assignee, the Landlord shall provide the Tenants with written notice of same and the Tenants shall have full rights to commence all actions to recover possession of the leased premises (in the name of Landlord, if necessary) and retain all rights for the duration of the said Lease provided it shall pay all accrued rents and cure any other default.
- c) There shall be no further assignment of lease without the prior written consent of Landlord.

6. This agreement shall be binding upon and inure to the benefit of the parties, their successors, assigns and personal representatives.

#### ACTION REQUESTED AT THE SEPTEMBER 14, 2007 BOARD MEETING

#### I. RECOMMENDED ACTION

The purpose of this staff report is to request Board Approval of the appointment of Heidi Curry to the Metro Advisory Committee (MAC) as the appointment of Director Kirby Nicol.

#### II. SUMMARY OF ISSUES

- On December 19, 2003 the Board of Directors approved the creation and structure of the Metro Advisory Committee (MAC).
- Each member of the Board nominated the name of an individual that they wanted to appoint for membership on the MAC.
- Paul Marcelin-Sampson, appointed by former Director Norton, was forced to resign due to relocation out of Santa Cruz County.
- Director Nicol is nominating Heidi Curry as the replacement for Paul Marcelin-Sampson.
- Pursuant to Section 3.2 of the MAC Bylaws the appointment of Heidi Curry would be for a term that concludes on September 12, 2009.

#### III. DISCUSSION

On December 19, 2003 after a significant amount of discussion and multiple meetings, the Board approved the creation of a new Metro Advisory Committee (MAC) that replaced the METRO Users Group (MUG), and the Board approved the structure of the new committee. Application Forms were used to solicit interested persons to participate on MAC.

The Board of Directors appointed the individuals that they wanted to serve as members of the MAC. Each member of the Board provided the name of the individual that they wanted to nominate. Former Director Dennis Norton appointed Paul Marcelin-Sampson as his representative to MAC. Mr. Marcelin-Sampson has resigned from MAC due to relocation

outside of Santa Cruz County. Director Nicol is requesting approval of Heidi Curry as his representative to MAC. Attachment A is Ms. Curry's Application Form for consideration. Also attached, as Attachment B is the Current Composition of the METRO Advisory Committee including Ms. Curry, should she be approved.

#### IV. FINANCIAL CONSIDERATIONS

The appointment of Heidi Curry will not have a financial impact on either the METRO Operating or Capital Budget.

#### BYLAWS FOR THE METRO ADVISORY COMMITTEE

Article I GENERAL PROVISIONS

#### §1.1 Purpose

These Bylaws govern the proceedings of the METRO Advisory Committee (MAC), an advisory committee established by the Board of Directors of the Santa Cruz Metropolitan Transit District (METRO).

#### §1.2 Construction of Bylaws

As used in these Bylaws, "Committee" means the METRO Advisory Committee. These Bylaws shall govern the Committee's proceedings to the extent they are not inconsistent with METRO Regulations or California or United States Statutes. These Bylaws become effective upon approval by the METRO Board of Directors

#### §1.3 Definitions

a. As used in these Bylaws, "chair" means the Chair of the Committee.

b. As used in these Bylaws, "vice chair" means the Vice Chair of the Committee.

c. As used in these Bylaws "staff" means staff members that are assigned to support the Committee by the METRO Secretary/General Manager.

#### Article II DUTIES AND AUTHORITY

#### §2.1 Duties

It shall be the duty of the Committee to provide advice to the Board of Directors on matters of METRO policy and operations referred to the Committee by the Board or Secretary/General Manager and to perform such additional duties as assigned by the Board. The Committee may also address issues which members or the public raise with respect to the quantity and quality of services provided by METRO.

#### §2.2 Limitations on Authority

The sole jurisdiction and authority of the Committee is to serve in an advisory capacity to the Board of Directors. It shall not have any authority to take actions that bind METRO or the Board of Directors with the exception that the Committee may design informational signs to be placed on the inside of buses and that the Committee may design and distribute an informational brochure to increase the public's knowledge of the operation and existence of the Committee. Communications by the Committee shall be to and through the Board of Directors. No individual member of the Committee shall be entitled to compensation from METRO, with the exception that Members of the Committee shall receive three (3) system-wide day passes for each monthly meeting that they attend, and any reimbursement for travel or other expenses shall receive specific prior authorization by the Board of Directors.

#### Article III MEMBERSHIP

#### §3.1 Membership

The Committee shall be composed of 11 members appointed by the Board of Directors as follows:

Each member of the METRO Board of Directors shall nominate 1 individual to serve as members of the METRO Advisory Committee. Appointments to the METRO Advisory Committee shall be made by the METRO Board of Directors.

All members shall be residents of the County of Santa Cruz. When making its appointments, the Board shall strive to balance the membership to reflect the ethnic, gender, and geographic diversity of the County. At least 4 of the individuals appointed to the Committee shall be persons with disabilities as evidenced by possession of a METRO Discount Photo Identification Card. No member of the Board of Directors or other elected public official shall be appointed to the Committee. No employee of METRO or any



agency that provides funding to, or contracts with, METRO shall be appointed to the Committee. However, individuals that have been selected to participate on the ADA Appeals Panel, to participate in the Bus Operator Sensitivity Training, or who are employed by the University of California, Santa Cruz in departments other than the Transportation and Parking Services (TAPS), or in the offices that directly supervise TAPS, shall be exempt from the financial/contracting prohibition for Committee members outlined in this section.

#### §3.2 Members' Terms

The term of membership of each Committee member shall be two years, commencing with the date of appointment by the METRO Board. Members may be reappointed for additional terms as approved by the METRO Board of Directors.

#### §3.3 Absences

If a member accumulates total absences from Committee Meetings of four, without excuse, and two, with excuse, in any twelve-month period, the position shall automatically be declared vacant. In the event of a known absence to an upcoming MAC Meeting it is expected of the MAC Member(s) that they will contact the Santa Cruz Metropolitan Transit District Front Office Administration Staff by telephone as soon as the occurring absence is known and no later than 12:00PM (noon) on the day of the meeting and that failure to make said contact will constitute an unexcused absence unless circumstances restrict such contact. The member of the Board of Directors that nominated such Committee member shall be notified of the vacancy so that they can nominate a successor to be appointed to fill the remainder of that Committee member's term.

#### §3.4 Vacancies

The member of the Board of Directors who nominated the original member shall nominate a replacement candidate to fill a position on the Committee that is declared vacant. The appointment of the replacement member shall be made by the Board of Directors.

#### Article IV OFFICERS

#### §4.1 Chair and Vice Chair

The Committee shall elect from its membership a Chair and a Vice Chair at its first meeting of the calendar year, to serve for a one-year term. The chair shall preside at all meetings of the Committee and represent the Committee before the Board of Directors. The Vice Chair shall perform the duties of the Chair when the Chair is absent. In the event of a vacancy in the chair's position, the vice chair shall succeed as chair for the balance of the Chair's term and the Committee shall elect a successor to fill the vacancy in the Vice Chair's position as provided below. In the event of a vacancy in the Vice Chair's position, the Committee shall elect a successor from its membership to fill the Vice Chair's position for the remainder of the vice chair's term.

#### §4.2 Staff Support

The Secretary/General Manager of METRO shall make arrangements to furnish clerical services to prepare and distribute the Committee's agendas, notices, minutes, correspondence and other materials. The METRO staff assigned to support the committee shall maintain a record of all proceedings of the Committee as required by law and shall perform other support duties to the committee as assigned by the Secretary/General Manager. The minutes of each meeting, when approved by the Committee, shall be transmitted to the METRO Board of Directors.

#### Article V MEETINGS

#### §5.1 Regular Meetings

Regular meetings of the Committee shall be held on the third Wednesday of each month. Whenever a regular meeting falls on a holiday observed by METRO, the meeting shall be held on another day or canceled at the direction of the Committee. A rescheduled regular meeting shall be designated a regular meeting.

#### **§5.2** Special Meetings

The Chair may call a special meeting. The meeting shall be called and noticed as provided in Section 5.3 below.

#### **§5.3** Calling and Noticing of Meetings

All meetings shall be called, noticed and conducted in accordance with the applicable provisions of the Ralph M. Brown Act (commencing with Section 54950 of the Government Code). The Secretary/General Manager and METRO Counsel shall be given notice of all meetings.

#### §5.4 Quorum; Vote

The presence of 6 members shall constitute a quorum for the transaction of business. However, when there are vacancies on the Committee the quorum shall be reduced to a majority of the number of Members appointed to the Committee, with the provision that a quorum shall never be less than four (4) Members. All official acts of the Committee shall require the affirmative vote of the majority of members present, providing that a quorum is maintained at all times.

#### §5.5 Thirty Minute Rule

If a quorum has not been established within thirty minutes of the noticed starting time for the meeting the meeting shall be cancelled.

#### §5.6 Matters Not Listed On the Agenda Requiring Committee Action

Except as provided below, a matter requiring Committee action shall be listed on the posted agenda before the Committee may act upon it. The Committee may take action on items not appearing on the posted agenda under any of the following conditions:

a. Upon a determination by an affirmative vote of the Committee that an emergency exists, as defined in Section 54956.5 of the Government Code.

b. Upon a determination by a two-thirds vote of the Committee, or if less than two-thirds of the members are present, a unanimous vote of those members present, there is a need to take immediate action and the need to take action came to the attention of the Committee subsequent to the agenda being posted.

#### §5.7 Time Limits for Speakers

Each member of the public appearing at a Committee meeting shall be limited to three minutes in his or her presentation, unless the Chair, at his or her discretion, permits further remarks to be made. Any person addressing the Committee may submit written statements, petitions or other documents to complement his or her presentation. Public



presentations that have been scheduled prior to the meeting with the Committee Chair shall not be subject to the time limits contained in this section.

#### §5.8 Impertinence; Disturbance of Meeting

Any person making personal, impertinent or indecorous remarks while addressing the Committee may be barred by the chairperson from further appearance before the Committee at that meeting, unless permission to continue is granted by an affirmative vote of the Committee. The Chair may order any person removed from the Committee meeting who causes a disturbance or interferes with the conduct of the meeting, and the Chair may direct the meeting room cleared when deemed necessary to maintain order.

#### §5.9 Access to Public Records Distributed at Meeting

Writings which are public records and which are distributed during a Committee meeting shall be made available for public inspection at the meeting if prepared by the METRO staff or a member of the Committee, or after the meeting if prepared by some other person.

#### Article VI AGENDAS AND MEETING NOTICES

#### §6.1 Agenda Format

The agenda shall specify the starting time and location of the meeting and shall contain a brief general description of each item of business to be transacted or discussed at the meeting. The description shall be reasonably calculated to adequately inform the public of the subject matter of each agenda item. The agenda may include recommendations for Committee action as appropriate.

#### §6.2 Public Communications

Each agenda for a regular meeting shall provide an opportunity for members of the public to address the Committee on matters of interest to the public either before or during the Committee's consideration of the item, if it is listed on the agenda, or, if it is not listed on the agenda but is within the jurisdiction of the Committee, under the agenda item heading "Oral/Written Communications". The Committee shall not act upon an item that is not listed on the agenda except as provided under Section 5.8. Each notice for a special meeting shall provide an opportunity for members of the public to directly address the Committee concerning any item that has been described in the notice for the meeting before or during consideration of that item.

#### §6.3 Agenda Preparation

The METRO Staff assigned to the Committee shall prepare the agenda for each meeting in consultation with the Chair. Material intended for placement on the agenda shall be delivered to the secretary on or before 12:00 Noon on the date established as the agenda deadline for the forthcoming meeting. The METRO Staff, in consultation with the chair, may withhold placement on the agenda of any matter that is not timely received, lacks sufficient information or is in need of staff review and report prior to Committee consideration.

#### §6.4 Agenda Posting and Delivery

The written agenda for each regular meeting and each meeting continued for more than five calendar days shall be posted by the METRO Staff at least 72 hours before the meeting is scheduled to begin. The written agenda for every special meeting shall be posted by the METRO Staff at least 24 hours before the special meeting is scheduled to begin. The agenda shall be posted in a location that is freely accessible to members of the public. The agenda together with supporting documents shall be transmitted to each Committee member, the Secretary/General Manager and the METRO Counsel at least five days before each regular meeting and at least 24 hours before each special meeting.

#### §6.5 Meeting Notices

The METRO Staff shall transmit notices of every regular meeting at least one week prior to the date set for the meeting to each person who has filed a written request with METRO for such notice as provided in Section 54954.1 of the Government Code. The notice shall be mailed at least one week prior to the date set for the meeting. Notice of special meetings called less than seven days prior to the date set for the meeting shall be given as soon as is practical.

#### Article VII MISCELLANEOUS

#### §7.1 Adoption and Amendment of Bylaws

These Bylaws shall be effective upon approval by the METRO Board of Directors.

#### §7.2 Committee Process

The intent of the Committee shall be to provide consensus based advice and recommendations to the METRO Board of Directors.

#### SUBJECT: CONSIDERATION OF APPROVING THE RECOMMENDATION OF THE BUS STOP ADVISORY COMMITTEE FOR THE LOCATION OF BUS SHELTERS THAT ARE READY TO BE INSTALLED.

#### **ACTION REQUESTED AT THE SEPTEMBER 14, 2007 BOARD MEETING**

#### I. RECOMMENDED ACTION

That the Board of Directors approve the recommendations of the Bus Stop Advisory Committee for the location of bus shelters that are now ready to be installed.

#### II. SUMMARY OF ISSUES

- METRO has used a variety of materials to provide passenger waiting shelters, the most recent being aluminum shelters with metal sides.
- The Board approved a contract with LNI Custom Manufacturing Co. to supply shelters.
- METRO's Bus Stop Advisory Committee has developed a priority list for the installation of the shelters.

#### III. DISCUSSION

The Santa Cruz Metropolitan Transit District (METRO) has used a variety of passenger waiting shelters at bus stops. In recent years, some of the wooden shelters which had direct wood-to-ground contact had to be removed, due to deterioration of the support column posts.

METRO has subsequently installed metal shelters, made of aluminum framework with perforated aluminum panels on the sides and back, and solid panel roofs. These aluminum shelters have proven to be durable and effective.

On March 23, 2007, the Board approved a multi-year contract with LNI Custom Manufacturing Co., for the supply of passenger waiting shelters. The initial order of ten (10) shelters has arrived, with the exception of some installation components, which are scheduled to arrive by the end of September.

METRO's Bus Stop Advisory Committee (BSAC) has developed an overall priority list for shelter installation. See Attachment A. As noted under each placement listing, some of the locations are shelter-ready, while others will require considerable work. bus stop, such as installing a shelter, the stop must be brought into compliance with the American's with Disabilities Act (ADA). Caltrans, and some jurisdictions require that a bus stop pad be placed in the street at stops when they are upgraded. In some instances, encroachment agreements also need to be executed, to allow the room required for an ADA compliant stop. Eight of the locations on the priority list are a simple shelter install. The rest all require varying degrees of permits, engineering, construction activity.

#### IV. FINANCIAL CONSIDERATIONS

There is funding in the Capital budget to support the engineering and construction activities associated with the shelter installation projects.

#### SUBJECT: CONSIDERATION OF CONTRACT EXTENSION WITH DEVCO OIL, INC. FOR DIESEL AND GASOLINE FUEL

#### **ACTION REQUESTED AT THE SEPTEMBER 14, 2007 BOARD MEETING**

#### I. RECOMMENDED ACTION

## It is recommended that the Board of Directors authorize the General Manager to enter into a one-year contract extension with Devco Oil, Inc. for diesel and gasoline fuel.

#### II. SUMMARY OF ISSUES

- The District has had a contract with Devco Oil, Inc. to provide diesel and gasoline fuel for the past five years.
- It is requested that the Board of Directors authorize the General Manager to execute an amendment to the contract to extend the contract term for one additional year.

#### III. DISCUSSION

The Santa Cruz Metropolitan Transit District requires the supply of diesel and gasoline fuel for use in its fleet. The estimated monthly requirements for this contract are 80,000 gallons of diesel fuel and 2,000 gallons of unleaded gasoline fuel per month. The District is still constructing its own fueling facility, so it is necessary for the fueling to be done off-site at the facilities of the provider of the fuels. Since each vehicle will have to be transported to the contractor's facility on a daily basis, it is imperative that the facility used for the delivery of fuel be within a 10-block radius of the District's Operations Facility at 1200 River Street.

When the construction of the MetroBase Fueling and Bus Wash Facility has been completed, and onsite fueling begins, the District will still need to have a contract for gasoline and a supplemental source for diesel fuel. The District has negotiated with Devco Oil, Inc. to provide fuel for one additional year under the same terms of reimbursement with a cancellation clause for either diesel and/or gasoline fuel with ten days written notice. Devco Oil, Inc. has provided excellent service over the past six years of the current contract. District staff recommends that the Board of Directors authorize the General Manager to sign a one-year contract extension on behalf of the District.

#### IV. FINANCIAL CONSIDERATIONS

Funding for this contract is contained in the Operating Budget. The annual budget for revenue and nonrevenue vehicle fuel is \$ 3,287,175.

#### SANTA CRUZ METROPOLITAN TRANSIT DISTRICT FOURTH AMENDMENT TO CONTRACT NO. 01-03 FOR SUPPLY OF DIESEL AND GASOLINE FUELS

This Fourth Amendment to Contract No. 01-03 for supply of diesel and gasoline fuels is made effective October 1, 2007 between the Santa Cruz Metropolitan Transit District, a political subdivision of the State of California ("District") and Devco Oil, Inc. ("Contractor").

#### I. RECITALS

- 1.1 District and Contractor entered into a Contract for supply of diesel and gasoline fuels ("Contract") on October 1, 2001.
- 1.2 The Contract allows for the extension upon mutual written consent.
- 1.3 The District requests the addition of a cancellation clause for either gasoline and/or diesel fuel.

Therefore, District and Contractor amend the Contract as follows:

#### II. TERM

2.1 Article 3.02 is amended to include the following language:

This contract shall continue through September 30, 2008. This Contract may be mutually extended by agreement of both parties.

#### III. ADDITIONAL CANCELLATION CLAUSE

3.1 District reserves the right to cancel the provisions for unleaded gasoline and/or diesel fuel by providing Contractor with ten (10) days written notice.

#### IV. REMAINING TERMS AND CONDITIONS

4.1 All other provisions of the Contract that are not affected by this amendment shall remain unchanged and in full force and effect.

#### V. AUTHORITY

5.1 Each party has full power to enter into and perform this Third Amendment to the Contract and the person signing this Third Amendment on behalf of each has been properly authorized and empowered to enter into it. Each party further acknowledges that it has read this Third Amendment to the Contract, understands it, and agrees to be bound by it.

#### ACTION REQUESTED AT THE SEPTEMBER 14, 2007 BOARD MEETING

#### I. RECOMMENDED ACTION

That the Board of Directors approve the transfer of service from AT&T to Pacific Telemanagment Services (PTS).

#### II. SUMMARY OF ISSUES

- Metro has received a Notice of Termination of Service provided by AT&T.
- Metro proposes Transfer of Service to Pacific Telemanagement Services (PTS) so as to continue payphone availability and to prevent removal of payphones.

#### III. DISCUSSION

Due to the impact cell phones have had on the demand for payphone usage, AT&T has found it to no longer be feasible to maintain payphones in certain locations. All SCMTD payphones were included in their analysis to be removed beginning September 15, 2007.

AT&T provided an alternative option to continue service with a different provider. Their recommendation is Pacific Telemanagement Services (PTS).

After researching all vendor options available to SCMTD regarding replacement of payphone service currently supplied by AT&T, it is recommended that the transfer of service to PTS would be the most economic solution. Findings are as follows:

#### A. <u>Commission Rate</u>

Current commission rate with AT&T is 17%. Transfer to PTS would bring the commission rate up to 25%.

#### B. <u>Transfer of Equipment</u>

All equipment replacements, repairs, or services would be handled between AT&T and PTS.
