SUBJECT: CONSIDERATION OF DECLARING ONE (1) 2003 CHEVROLET VENTURE PARATRANSIT VAN AS EXCESS FOR PURPOSES OF DISPOSAL OR AUCTION

I. RECOMMENDED ACTION

That the Board of Directors declares one (1) 2003 Chevrolet Venture Paratransit Van as excess for purposes of disposal or auction and direct staff to use appropriate action for disposal.

II. SUMMARY OF ISSUES

- In accordance with Santa Cruz METRO's policy on disposal of fixed assets and inventoriable items, at least once per year the Finance Manager shall recommend to the Board of Directors a list of items to be declared excess with appropriate action for disposal.
- One (1) 2003 Chevrolet Venture Paratransit Van has exceeded its useful life and is no longer required by Santa Cruz METRO.
- Staff recommends that the Board of Directors declare the above item as excess and direct staff to use appropriate action for disposal.

III. DISCUSSION

In accordance with Santa Cruz METRO's policy on disposal of fixed assets and inventoriable items, at least once per year the Finance Manager shall recommend to the Board of Directors a list of items to be declared excess with appropriate action for disposal.

One (1) 2003 Chevrolet Venture Paratransit Van has exceeded its useful life and is no longer required by Santa Cruz METRO.

Staff recommends that the Board of Directors declare the item on **Attachment A** as excess and direct staff to use appropriate action for disposal.

The current gross market value of the van is approximately \$500.00 as it is in poor condition.

SUBJECT: STATUS REPORT OF ACTIVE GRANTS AND SUBMITTED GRANT PROPOSALS FOR AUGUST 2012

I. RECOMMENDED ACTION

This report is for informational purposes only. Active grants and grant proposals are current as of August 13, 2012. No action is required.

II. SUMMARY OF ISSUES

- Santa Cruz METRO relies upon grant funding from other agencies for more than 25% of its FY13 operating revenue and more than 90% of its FY13 capital funding.
- A list of Santa Cruz METRO's active grants (Attachment A) and a list of grant proposals for new funds (Attachment B) are provided monthly in order to apprise the Board of the status of grants funding.
- Santa Cruz METRO has active grant awards totaling \$39,771,627.
- Items in **bold** on Attachments A and B depict changes from last month's report.
- Santa Cruz METRO staff is developing new applications totaling \$12,800,115 for operating and capital projects.

III. DISCUSSION

Santa Cruz METRO relies upon grants from a number of other entities throughout the year for more than 25% of its FY13 operating revenue and over 90% of its FY13 capital funding. Programs such as the Transportation Development Act (TDA) and the Federal Transit Administration (FTA) urbanized area program annually allocate funds by formula while others such as the Monterey Bay Unified Air Pollution Control District's AB2766 Motor Vehicle Emissions Reduction Program and the California Department of Transportation (Caltrans) discretionary planning grants are competitively awarded based on merit. Santa Cruz METRO relies on both formula and discretionary grant revenue to support its operating and capital budgets.

This staff report is to apprise the Board of Directors of active grants funding current projects and proposed grants for new projects and ongoing operating costs. Attachment A lists all of Santa Cruz METRO's active grants with the award amount, the remaining balance and the status of the

projects funded by the grant. Attachment B lists Santa Cruz METRO's open grant applications with a brief description, source and status of proposed funds. Items in **bold** on Attachments A and B depict changes from last month's report.

IV. FINANCIAL CONSIDERATIONS

Active grant awards for operating and capital projects total \$39,771,627 with an unspent balance of \$21,408,024. The total amount of active grant awards decreased by more than \$11 million due to completed projects being removed from the list. Closure of the ARRA-funded farebox and ParaCruz van replacements and FY12 TDA operating assistance grant account for more than \$10 million of the reduction. The unspent balance decreased from last month because of project spending from open grants.

Current grant applications request \$12,800,115 in new funds, an increase of \$9,694,063 since the last report due to the addition of an FTA 5307 operating assistance application for the previous year's operations and the addition of the application for Prop 1B SLPP funds for the Operations Building. Staff will continue to evaluate new grant opportunities as they arise.

I. RECOMMENDED ACTION

This report is for informational purposes only. No action is required

II. SUMMARY OF ISSUES

- Total ridership for the month of June 2012 was 381,516, which is a increase of 1,157 riders or 0.03% versus June 2011. System Daily Averages for June include:
 - 14,678 riders per Weekday, a loss of 0.56% (83 riders)
 - 8,377 riders per Saturday, a gain of 11.37% (855 riders)
 - 7,846 riders per Sunday, a gain of 23.01 % (1,468 riders)
- Highway 17 Express ridership for the month of June 2012 was 26,784, which is a increase of 1,216 riders, or 4.76%, from June 2011. Daily averages include:
 - 985 riders per Weekday, a gain of 4.16% (39 riders)
 - 679 riders per Saturday, a gain of 11.84% (72 riders)
 - 677 riders per Sunday, a gain of 15.83% (93 riders)
- UCSC students and staff/faculty generated 144,481 rides in June 2012, a gain of 20.44%. Revenue generated from UCSC was \$186,390.18, a 21.84% increase from June 2011.
- Overall, system wide ridership experienced a decrease of 6.07% from FY 2011 to FY 2012 in part due to a service reduction that was implemented on September 15, 2011 which resulted in 8.2% less service from September to late March.

III. DISCUSSION

In the twenty-one (21) weekdays, five (5) Saturdays, and four (4) Sundays of June 2012, Santa Cruz METRO's total ridership was 381,516 riders. This was a small gain from the previous year, increasing by 1,157 riders or 0.03%. The month over month losses in ridership have seemed to bottom out as service was restored on March 29, 2012. Also, there were more school term service days in June 2012, which is a major factor for the strong ridership numbers. FY12 total ridership was 5,373,217 which was under FY11 by 6.07%.

Attachment A shows that during June 2012, Santa Cruz METRO averaged 14,678 riders per Weekday. This was only a small loss from the previous June of 0.56% which is most likely due

to riders reacting to newly restored service. Saturdays experienced a gain of 11.37% and Sundays experienced a gain of 23.01%, as the UCSC commencements increased demand for choice weekend travel.

Attachment A also shows Highway 17 Express total ridership at 26,784 riders, a new all time record for the month of June. This was a gain from the previous year, increasing by 1,216 riders or simply 4.76%.

FY12 average weekday ridership on the Highway 17 Express was 985 riders per weekday, a 4.16% increase per weekday. Simultaneously Highway 17 Express has seen ridership gains 11.84% on Saturdays and a gains of 15.83% Sundays. These variations in ridership could possibly be due to sustained higher gas prices leading commuters to look for alternatives modes of transportation, and weekend travel demands from UCSC students would be altered due to spring break.

Attachment B shows UCSC ridership increase over June 2011, mainly due to more school term days than the year prior. In June 2012, UCSC generated 144,481 rides between students and staff/faculty. This accounts for almost 38% of Santa Cruz METRO's total ridership count. On School Term Days, ridership decreased 2.47%, while Weekdays experienced gains of 18.38% and Weekend days experienced a 58.68% increase in ridership. Total revenue derived from UCSC in June 2012 was \$186,390.18 a 21.84% decrease from June 2011.

Attachment C depicts Weekday, Saturday, and Sunday ridership by route. Many of Santa Cruz METRO's main-lines routes are well riden while overall ridership is experiencing a loss over the previous year. Overall, system wide ridership YTD decreased 6.29 % in part due to a service reduction that was implemented on September 15, 2011 which resulted in 8.2% less service than in the prior year.

Attachments D & E: Due to availability of data and the meeting schedule of the Board of Directors, ridership reports for April and May were skipped. A summary of those months can be found in Attachments D and E.





II. SUMMARY OF ISSUES

- METRO ParaCruz is the federally mandated ADA complementary paratransit program of the Transit District, providing shared ride, door-to-door demand-response transportation to customers certified as having disabilities that prevent them from independently using the fixed route bus.
- METRO assumed direct operation of paratransit services November 1, 2004. This service had been delivered under contract since 1992.

III. DISCUSSION

From April 2012 to May 2012, ParaCruz rides increased by 873 rides. The increase in rides does trend typically with the previous two years. The increase is attributed to spring break at the Cabrillo Stroke and Disability Learning Center, which happened in April.

The number of rides performed in May 2012 was 440 less than the number of rides performed in April 2011.

From May 2012 to June 2012, ParaCruz rides decreased by 1320 rides. The decrease is attributed to summer break at the Cabrillo Stroke and Disability Learning Center, which started at the beginning of June.

The number of riders performed in June 2012 was 538 less than the number of rides performed in June 2011.

For June 2012, there were six missed trips, five of which occurred on June 25, the day the cement truck overturned on Hwy 1 and snarled traffic in the county for most of the day.





TOTAL RIDES vs. SHARED RIDES




NUMBER OF RIDES COMPARISON CHART





SUBJECT: ACCESSIBLE SERVICES REPORTS FOR MAY AND JUNE 2012

I. RECOMMENDED ACTION

This report is informational only. No action required.

II. SUMMARY OF ISSUES

- After a demonstration project, the Accessible Services Coordinator (ASC) position became a full time position to organize and provide METRO services to the senior/older adult and disability communities.
- Services include the METRO Mobility Training program and ongoing public outreach promoting METRO's accessibility. The ASC also participates in METRO's staff training and policy review regarding accessibility.
- Two persons have served in the ASC position from 1988 to today. In 2002 the ASC position was moved into the newly created Paratransit Department. On May 27, 2011 the Board approved the staff recommendation to receive monthly reports on the activity of the ASC.

III. DISCUSSION

The creation of the Accessible Services Coordinator (ASC) position was the result of a successful demonstration project funded through the Santa Cruz County Regional Transportation Commission. Two persons have served in the ASC position from 1988 to today. Both hiring panels for the ASC included public agency representatives serving older adults and persons with disabilities.

The first ASC, Dr. Pat Cavataio, served from April 1988 through December 1998. The second ASC, John Daugherty, began serving in December 1998.

Under direction, the Accessible Services Coordinator: 1) Organizes, supervises, coordinates and provides METRO services to the older adult and disability communities; 2) Organizes, directs and coordinates the activities and operation of METRO's Mobility Training function; 3) Promotes and provides Mobility Training and outreach services; 4) Acts as information source to staff, Management, funding sources, clients, community agencies and organizations, and the general public

regarding Mobility Training and accessibility; 5) Works with Department Managers to ensure compliance with METRO's accessibility program and policies.

During 2002 the ASC position was moved from Customer Service to the newly created Paratransit Department. Mr. Daugherty was the first employee. His placement was followed by hiring of the first Paratransit Superintendent, Steve Paulson and the current Eligibility Coordinator, Eileen Wagley.

On May 27, 2011 the Board approved the following recommendation: "Staff recommends that this position be reinstated in FY 12 budget with the requirement that this position be evaluated during FY12 to make sure the service items that are being requested by the Community are being carried out by this position. Additionally, staff recommends that this position be required to provide a monthly activity report to the Board of Directors during FY12."

Accessible Services Coordinator (ASC) Activity Tracking Report for May 2012

What is Mobility Training?

Mobility Training is customized support to allow access to METRO services. It can include:

- An Assessment: The ASC meets the trainee to assess the trainee's capabilities to use METRO services. They discuss the trainee's experience using public transit and set goals for training sessions.
- Trip Planning: Practice to use bus route schedules, maps, online resources and other tools to plan ahead for trips on METRO fixed route and METRO ParaCruz services. All Mobility Training includes some trip planning.
- Boarding/Disembarking Training: Practice to board, be secured, and then disembark (get off) METRO buses. This training has been requested by persons using walkers, wheelchairs, scooters and service animals. The training session includes work with an operator and out of service bus and lasts three to five hours.
- Route Training: Practice using METRO buses to travel to destinations chosen by trainees. The training session includes practice on handling fares, bus riding rules and emergency situations. One training session can take two to eight hours. One or two sessions to learn one destination is typical. The number of training sessions varies with each trainee.

During May 2012 there was progress with nine trainees:

- One person successfully completed her Boarding/Disembarking Training.
- She also completed her first and second Route Training sessions.
- Training with three other persons progressed: Two persons completed their second Route Training sessions. The ASC spoke to another person, who was tentative about setting up an Assessment.
- Training with five persons is almost complete: May activity included checking on whether further training is needed and preparation to close their files or complete their referral sheets.



I. RECOMMENDED ACTION

Authorize the General Manager to execute a contract with Feeney Wireless, LLC for On-Board Bus Wi-Fi Service and Equipment in an amount not to exceed \$60,000 and designate Ciro Aguirre, Operations Manager, as Contract Administrator.

II. SUMMARY OF ISSUES

- Santa Cruz METRO has a successful wireless internet program currently on-board seventeen (17) of our Highway 17 fleet. The current provider has reported that our usage continues to be some of the highest usage they have seen around the country in similar programs.
- Due to the popularity and high level of demand for wireless internet, Santa Cruz METRO would like to increase the number of buses able to provide this service. This will also be an opportunity to upgrade the equipment and service for faster speeds and better coverage.
- A formal request for proposals was conducted to solicit proposals from qualified firms.
- One firm submitted a proposal for Santa Cruz METRO's review.
- A three-member evaluation committee comprised of Santa Cruz METRO staff reviewed and evaluated the proposals and is recommending a contract award to Feeney Wireless, LLC.

III. DISCUSSION

Santa Cruz METRO has a successful wireless internet program currently on-board seventeen (17) of our Highway 17 fleet. Eurotech, the current provider, has reported that our usage continues to be some of the highest usage they have seen around the country in similar transit programs.

Due to the popularity and high level of demand for wireless internet on this mainly commuter route, Santa Cruz METRO would like to increase the number of buses able to provide this service. This will also be an opportunity to upgrade the equipment and service for faster speeds and better coverage.

On July 3, 2012, Santa Cruz METRO Request for Proposal No. 12-31 was mailed to fifteen (15) firms, was legally advertised, and a notice was posted on Santa Cruz METRO's web site. On August 7, 2012, proposals were received and opened from one (1) firm – Feeney Wireless, LLC. A sole bid analysis was required due to only one proposal being received. That analysis determined that there was a limited pool of firms that could provide both the equipment and the required installation, integration and maintenance services. They were typically providers of one or the other. The current contract holder, Eurotech, failed to submit a bid and has not responded to inquires as to why. SUBJECT: CONSIDERATION TO PURCHASE GFI GENFARE TICKET VENDING MACHINE (TVM) FOR INSTALLATION AT THE CAVALLARO TRANSIT CENTER, SCOTTS VALLEY, CA.

I. RECOMMENDED ACTION

That the Board of Directors authorize the purchase of a GFI Genfare TVM for the Cavallaro Transit Center in Scotts Valley.

II. SUMMARY OF ISSUES

- In March 2012 satellite ticket vendor Epic Adventures located in Scotts Valley advised METRO that they would cease selling Santa Cruz METRO tickets and passes.
- Café Amigo opened for business within the Cavallaro Transit Center in April 2012, and as part of their lease agreement their staff was trained in selling tickets and passes as well as providing METRO information.
- Café Amigo operates from 6am to 6:30pm Monday through Friday, 8:30am to 4pm Saturdays, and is closed on Sundays.
- Customer patronage at the Cavallaro Transit Center has increased due to the opening of the Scotts Valley Library, Café Amigo, accessibility to Route 35 and Highway 17 services
- Staff has determined that a need exists, due to increased patronage at the Cavallaro Transit Center, to provide after-hours availability of tickets, passes, and Smart Card value loading options.
- Staff recommends that the METRO Board of Directors approve the purchase and installation of an additional TVM for use at the Cavallaro Transit Center.

III. DISCUSSION

In March 2012 METRO's satellite ticket and pass vendor Epic Adventures located in the Kings Village Shopping Center in Scotts Valley advised METRO that they no longer wished to be part of METRO's satellite vendor program and would cease ticket and pass sales commencing April 01, 2012.

METRO Customer Service staff performed training with staff at Café Amigo and upon opening at the Cavallaro Transit Center in April 2012 Café Amigo began providing METRO tickets, passes, and information.

Café Amigo is open Monday through Friday from 6am to 6:30pm, Saturdays 8:30am to 4pm and is closed Sundays.

Due to increased patronage at the Cavallaro Transit Center, staff has determined that a Ticket Vending Machine installed at the Cavallaro Transit Center will provide after-hours ticket and pass purchasing and Smart Card value loading options, which will add a higher level of convenience to METRO riders.

Staff recommends that the METRO Board of Directors approve the purchase of the GFI Genfare Ticket Vending Machine in the amount quoted (Refer to Attachment A). This will be Sole source procurement due to the GFI Genfare TVM having unique availability. Ms. Erron Alvey, METRO Purchasing Agent will prepare a Sole Source Justification before placing any order.

SUBJECT: CONSIDERATION OF ADOPTION OF A MANAGEMENT COMPENSATION PROGRAM FOR THE UNREPRESENTED EMPLOYEES FOR THE TIME PERIOD JULY 2012-JUNE 2015 CONTAINING 2% WAGE INCREASES FOR EACH OF THE THREE YEARS.

I. RECOMMENDED ACTION

That the Board of Directors adopt a Management Compensation Plan for the unrepresented employees at METRO for the time period July 2012-June 2105 containing 2% wage increases for each of the three years as well as adjustments in Annual Leave accruals and Holidays.

II. SUMMARY OF ISSUES

- METRO recently concluded the collective bargaining process with the three employee bargaining units.
- The unrepresented employees at METRO are covered by a Management Compensation Plan.
- The provisions of the Management Compensation Plan are typically revised at the conclusion of the collective bargaining process with the represented employees.
- A Proposed Management Compensation Plan for the time period of July 2012 June 2015 is attached to this Staff Report.
- The Proposed Management Compensation Plan contains a 2% increase in salary levels for each of the three years of the Plan.
- Increases in the number of paid Holidays and Annual Leave accruals are included in the Proposed Management Compensation Plan.
- The wages and benefit improvements included in the Proposed Management Compensation Plan are consistent with the recent collective bargaining settlements.

III. DISCUSSION

Over the past six months METRO and the three labor organizations have been involved in the collective bargaining process. One of the goals of the collective bargaining process was to attempt to achieve equity and uniformity in many of the benefit components of the Labor

Agreements. To that end we added longevity payments to the two United Transportation Union Contracts and additional Holidays to the Service Employees International Union Memorandum of Understanding. Additionally, the wage adjustment proposed to all three bargaining units was 2% per year for each year of the contracts.

The Proposed Management Compensation Plan addresses wages and benefits for the nonrepresented personnel at METRO. Attached to this Staff Report is the proposed Management Compensation Plan for the period July 2012/June 2015. The proposed Management Compensation Plan would increase wage level by 2% each of the three years of the Plan. Additionally, the proposed Plan would increase Holidays and Annual Leave levels to make them commensurate with SEIU workers. The exhibits attached to this Staff Report outline the proposed changes.

IV. FINANCIAL CONSIDERATIONS

The three year total of increased cost to METRO of approval of the Proposed Management Compensation Plan is estimated to be \$402,398.

I. MANAGEMENT POSITIONS

An employee in a regular budgeted management position identified in Exhibit A is engaged in developing, implementing or recommending policy and in affecting employer-employee relations, and shall receive salary and benefits as provided in this plan.

II. PROBATIONARY STATUS

An employee shall serve a probationary period for twelve (12) months following the date of appointment or promotion to a regular budgeted management position.

III. SALARY PLAN

- A. Management salary schedules are listed in Exhibit A.
- B. Longevity

Santa Cruz METRO shall compensate an employee with longevity increments as follows:

- 5.0% of the base salary after ten years continuous service.
- An additional 5.0% of the base salary after fifteen years continuous service.

C. Supplemental Cash Payment In the payroll period of June 21, 2012, employees covered by the Management Compensation plan will receive a \$1,750 supplemental cash taxable payment.

IV. HEALTH & WELFARE BENEFITS

A. Medical Insurance

Santa Cruz METRO shall provide medical insurance coverage for an employee, retiree and eligible dependents under the provisions of CaIPERS. Santa Cruz METRO shall pay premiums at a level sufficient to cover the cost of the basic monthly medical insurance premiums for HMO plans offered in Santa Cruz County by the CaIPERS medical program. Santa Cruz METRO will continue to offer the H-Care Plan (IRC Section 125 pre-tax medical reimbursement plan) as allowed by the County of Santa Cruz. The amount Santa Cruz METRO pays towards medical premiums for retirees will be consistent with the premium participation amount specified in the Management Compensation Plan in effect at the time of the individual's retirement or the amount stated in Santa Cruz METRO's contract with CaIPERS, whichever is greater. Qualifying individuals who retired prior to July 1st 2005 shall continue to receive supplemental premium payments in accordance with Santa Cruz METRO's Retiree supplemental Premium Participation Plan adopted August 25th, 2006.

An employee who declines participation in Santa Cruz METRO's medical insurance program and produces satisfactory evidence of other medical insurance coverage shall be paid \$300 for each full three calendar month quarter beginning January 1 of each year while in active service and in which Santa Cruz METRO paid coverage would have been provided had Santa Cruz METRO's medical program been elected.

B. Dental Insurance

Santa Cruz METRO shall provide paid dental insurance coverage for an employee and eligible dependents.

C. Vision Insurance

Santa Cruz METRO shall provide paid vision insurance coverage for an employee and eligible dependents.

D. Life and AD&D Insurance

An employee shall be entitled to a \$50,000 term life and AD&D insurance policy paid by Santa Cruz METRO plus \$150,000 in optional supplementary life and AD&D insurance paid by the employee.



E. Survivor's Benefits

Upon the death of a covered employee, who is on Santa Cruz METRO's payroll and has dependents covered under Santa Cruz METRO's medical, vision and dental plans, Santa Cruz METRO's share of coverage of the eligible dependents shall continue for twenty-six (26) consecutive pay periods.

F. Retirement Benefits

An employee shall be enrolled in the Public Employees Retirement System (PERS) including the third level 1959 Survivors benefit as allowed by PERS. The Employee shall pay the "employee share" of PERS up to a maximum of eight percent.

Dental, vision, and life insurance plan coverage shall be provided by Santa Cruz METRO for an employee retired under the provisions of PERS and the employee's dependents until the retired employee reaches age 65 To qualify for this benefit, the retired employee shall have been an employee of Santa Cruz METRO for the equivalent of ten (10) full-time years immediately prior to the date of retirement and reached the age of 50 years.

G. State Disability Insurance

Santa Cruz METRO shall provide paid coverage for an employee for State Disability Insurance.

H. Long Term Disability Insurance

Santa Cruz METRO shall provide for a long term disability insurance plan (LTD). The plan shall provide for monthly payments to an eligible employee of up to \$10,000 per month. The plan shall start LTD one year and one month after month of hire

I. Deferred Compensation Plan

Santa Cruz METRO shall provide a deferred compensation plan to an employee.

J. Industrial Injury

An employee shall be entitled to workers compensation insurance to be provided by Santa Cruz METRO.

K. Continuation of Insurance during an Unpaid Leave of Absence

An employee who is on an unpaid leave of absence exceeding one hundred eighty (180) calendar days must pay the total monthly premiums in advance to continue medical, dental and vision insurance coverage. Failure of an employee to make advance payments for insurance coverage shall result in the employee and any dependent(s) being dropped from the plans.

L. Principal Domestic Partner Coverages

Santa Cruz METRO medical, dental and vision insurance coverages may be extended to an employee's principal domestic partner (PDP) while the employee's own coverages are being paid by Santa Cruz METRO. In the absence of the PERS Medical Program allowing for PDP coverage, reimbursement of monthly premiums may be made to an individual medical plan to a maximum of \$185.

V. HOLIDAYS

An employee shall be entitled to the following holidays with pay:

Thanksgiving Day Christmas Day New Year's Day



Effective July 1, 2012 an employee shall also be entitled to the following holidays with pay: Labor Day Independence Day Memorial Day

Effective July 1, 2013 an employee shall also be entitled to the following holidays with pay: Martin Luther King Jr. Day Employee's Birthday

For an employee's birthday falling on February twenty-ninth (29th), the twenty-eighth (28th) day of February will be observed as the employee's birthday in years other than leap years. If an employee's birthday falls on the same day as a paid holiday the employee will be allowed to take the day off and receive the regular hourly rate for the holiday and the equivalent number of hours at the regular hourly rate for their birthday holiday, or, have the equivalent number of hours at the regular hourly rate for their birthday holiday added to his/her annual leave accrual.

In addition to the above-specified days, an employee may choose any (11) eleven additional days as floating holidays or when working a partial year, a prorated number of days as determined by the General Manager. An employee shall be compensated for any unused floating holiday time at the end of the fiscal year at the employee's regular rate of pay, not to exceed the total of eighty-eight (88) when combined with Administrative Leave.

An employee shall be entitled to receive any special non-recurring holiday designated as an official State holiday by the Governor of the State of California or as an official national holiday by the President of the United States, subject to the approval of the Board of Directors.

Upon departure from Santa Cruz METRO for any reason, an employee shall be compensated for any unused holiday time at the employee's hourly rate.

VI. PAID LEAVES

A. Annual Leave

An employee shall accrue annual leave at the following rates:

- a for the first five years of employment.....ten (10) days/year
- b. between five and nine years of employment.eighteen (18) days/year

Upon approval of the General Manager an employee shall be permitted to take a minimum of two weeks annual leave each calendar year.

An employee shall accrue the pro-rata portion of annual leave for which he/she is entitled for each pay period or major fraction thereof, for which he/she is in paid status.

An employee may not carryover into the next fiscal year more than (3) three times the annual allotted time. Annual leave accumulated beyond two hundred (200) hours shall upon two (2) weeks advance written request of the employee, be paid to the employee based on the employee's current base hourly rate. Payment shall be made in the subsequent pay period.

Upon departure from Santa Cruz METRO for any reason, an employee shall be compensated for any unused annual leave at the employee's regular rate.



B. Sick Leave

An employee shall be entitled to sick leave with pay at the rate of one day for each month of employment. Sick leave shall mean personal illness or physical incapacity caused by factors over which the employee has no reasonable immediate control, or the illness of a member of the immediate family of such employee which illness requires his/her personal care and attention. Immediate family shall include the parent, spouse, and children, brother, or sister of the employee.

An employee who has accumulated sick leave above 120 days (960 hours) may elect to receive a cash payment of 25% of the accrued sick leave above 120 days in lieu of retaining excess sick leave credits. Any sick leave accrued beyond a balance of 96 hours may, at the option of the employee, be converted to annual leave. All unused sick leave accrued shall be paid to an employee who retires immediately upon leaving Santa Cruz METRO under the provisions of PERS.

C. Administrative Leave

An employee shall be entitled to eighty (80) hours of administrative leave each year in lieu of overtime or when working a partial year, a prorated amount as determined by the General Manager. Upon approval of the General Manager, time worked in excess of eighty hours in a pay period may be saved and taken as time off in another pay period when the extra hours are earned through participation in unusual, lengthy activities which require the presence of the employee in meetings, hearings, or negotiations.

Administrative leave not taken during the fiscal year is lost. Upon the approval of the General Manager, an employee may elect to convert up to eighty (80) hours of Administrative Leave to a bonus payout. In no case will the Administrative Leave and the Floating Holiday amount paid to the employee total more than eighty-eight (88) hours.

D. Personal Leave

An employee shall be entitled to use 40 hours per year of personal leave, chargeable to accumulated sick leave.

E. Bereavement Leave

An employee shall be granted a leave with pay in the event of the death of any member of the employee's family. The leave shall be for a period of three (3) working days, five (5) working days if travel is required in excess of 350 miles. The family member is defined as spouse, parent, grandparent, sister, brother, child, grandchild, foster parent, stepparent, foster child, stepchild, father-in-law, mother-in-law, brother-in-law, sister-in-law, nieces, nephews, aunt, uncle, or any person living in the immediate household of the employee.

F. Hospice and Critical Care Leave

An employee shall be granted necessary leaves up to four (4) months for the care of a critically ill family member with appropriate verification. An employee shall be paid for these absences from his/her sick leave or annual leave accruals.

G. Paid Birth/Adoptive Leave

An employee is entitled to forty hours leave with pay at or about the time of the birth of the employee's child or at the time of adopting a child. The paid leave shall be within two months of the birth or adoption or at the employee's option at the expiration of State Disability Insurance payments.

H. Jury Duty

An employee required to report for jury duty (except for Grand jury) or to answer a subpoena, as a witness shall be granted leave with full pay until released by the court. An employee shall have court-paid per diems deducted from his/her daily pay during jury duty assignment.



I. Paid Military Leave

An employee in permanent status who is required to attend summer military training exercises as part of his/her military reserve obligation, shall be granted paid military leave not to exceed thirty (30) working days annually.

VII. UNPAID LEAVES OF ABSENCE

A. Maternity/Childcare Leave

Maternity/childcare leave shall be granted for a maximum period of twelve (12) months. If an employee does not have a sufficient paid leave balance to cover the period of absence, an unpaid leave of absence shall be granted.

B. FMLA / CFRA

Santa Cruz METRO will comply with the Family Medical Leave Act and the California Family Rights Act, as amended. Generally these Acts provide for up to twelve weeks leave for a serious health condition of the employee or an eligible family member and the employee has worked 1,250 hours in the twelve month period preceding the leave. Accrued sick leave must be used before any unpaid leave. This FMLA/CFRA leave will run concurrently with any other absence due to an employee's serious health condition.

VIII. EXEMPT MANAGEMENT PROVISION

An employee who has exhausted all leave accruals shall not have his/her salary reduced by being absent from work on an authorized absence of less than one full day.

IX. OTHER BENEFITS

A. Training

An employee shall be authorized to attend transit seminars and workshops, and to visit other properties as part of his/her ongoing job duties, and shall be compensated for receipted expenses incurred in so doing.

An employee may request release time and reimbursement of expenses for course work relevant to the employee's current duties and area of responsibility.

Expenses, which may be reimbursed, include tuition, fees, meals and books. For courses, which require an overnight stay out-of-town, the employee may receive a pro-rata meal allowance of \$20 per diem at the discretion of the General Manager.

Reimbursement will be made for academic or professional credentials, certifications, and/or degrees for courses directly related to the employee's current position, specific job tasks and areas of responsibility.

Approval of release time and reimbursement of expenses is at the discretion of the General Manager and subject to the demonstrated cost-benefit ratio of the training and the current workload of the employee.

B. Mileage reimbursement

If Santa Cruz METRO requires an employee to use the employee's private insured automobile to conduct Santa Cruz METRO business, the employee shall be reimbursed for automobile expenses at the rate established annually by the IRS.



C. On Call duty

If an employee is required to be on call, they shall be offered access to a Santa Cruz METRO vehicle in order to provide for home to work transportation. "On call" shall be defined as the requirement for the employee to report to work after or before normal duty hours to perform the functions, which cannot otherwise be performed during regular duty hours. When an employee is assigned such duties on a regular basis, he/she may be assigned a car for home to work transportation on a regular basis. If such work is assigned on a periodic or occasional basis, the assignment of a car for home to work transportation shall be on an as-needed basis only, as approved by the General Manager. The staff car assigned on an on-call basis to an employee shall be used to provide transportation only between the home and the work place. It shall not be used to make intermediate stops or for any other personal use. During normal duty hours, staff cars are similarly restricted for use only for official business of Santa Cruz METRO.

D. Communication Allowance

When approved by the General Manager, an employee may receive a communication allowance of \$75 each two-week pay period. An employee on approved Santa Cruz METRO travel with the General Manager's approval, may be reimbursed for eligible roaming and long distance charges.

X. LAYOFF

A. Insurance

An employee separated from Santa Cruz METRO service as a result of layoff shall have his/her insurance benefits paid by Santa Cruz METRO at the same level while employed for a period of ninety (90) days from the date of separation.

B. Severance Pay

An employee laid off shall be given a severance payment equal to eight (8) hours at the base hourly rate for each 2,080 hours of active service up to a maximum of eighty (80) hours severance pay.

SUBJECT: STATUS REPORTS OF FEDERAL AND STATE LEGISLATION AND CURRENT LEGISLATIVE ISSUES

I. RECOMMENDED ACTION

That the Board of Directors accept and file the status reports of Federal and State legislation and current legislative issues through August 16, 2012.

II. SUMMARY OF ISSUES

- Status reports on Congress's, the State Assembly's and Senate's legislative issues are provided monthly to inform the Board of the status of Federal and State legislation of interest to Santa Cruz METRO.
- This month's Federal and State reports reflect pertinent legislative activities which occurred June 14, 2012 August 16, 2012. The Board did not meet in July 2012, so this report covers two months' worth of activity.
- The House and Senate Conference Committee were able to produce a compromise bill, HR 4348, aka MAP-21, a result of Hurculean staff effort on Capitol Hill, as well as the relentless work of California Senator Boxer. MAP-21 was signed on July 6, 2012 and will sunset on September 30, 2014.
- Small Transit Intensive Cities (STIC) funding in MAP-21, a merit-based funding program rewarding smaller systems, has been increased from 1% of total urbanized area funding to 1.5%, a revenue bump estimated to be in the \$500,000 \$750,000 range for Santa Cruz METRO.
- Congress passed a six-month Continuing Budget Resolution to save contentious budget discussions until post-election. Republican Presidential candidate and presumed nominee Romney chose Rep. Ryan (R-WI) as his running mate. Rep. Ryan is the author of the House budget including draconian cuts to public transportation.
- The Senate Finance Committee passed a "Tax Extenders" package including the alternative fuel tax credit worth up to \$750,000/year to Santa Cruz METRO, as the CNG fleet grows. It may be heard on the Senate floor following the August recess.
- Please see Attachments A and B for all federal legislation and issues being monitored, including running mates and the federal budget. A six-month budget continuing resolution was passed on July 31, 2012 in order to delay this challenging discussion until post-election.

- On August 22, 2012, S anta Cruz METRO anticipates a \$5.812 million State and Local Partnership Program (SLPP) allocation from the California Transportation Commission (to be matched with local funds), to be used for the Metro Base project.
- The FY13 State Budget will also depend on the election in November, and revenues are still not matching estimates. Painful budget cuts/revisions will depend on the November outcomes.
- Santa Cruz METRO is monitoring legislation regarding bus axle weight, the budget and proposal to create a single transportation agency, and the AB-32-mandated Cap and Trade Program. **Please see Attachments C and D**.

III. DISCUSSION

Status reports on Congress's, the State Assembly's and Senate's legislative issues are provided monthly to inform the Board of the status of Federal and State legislation of interest to Santa Cruz METRO. This month's Federal and State reports reflect pertinent legislative activities which occurred June 14, 2012 – August 16, 2012. The Board did not meet in July, so this report covers two months' of activity.

At last report, it was uncertain that a transportation bill could pass, and almost guaranteed that a tenth Continuing Resolution of SAFETEA-LU was in the works. It was, but only for a week. On June 29, 2012, the Senate had approved the Conference Committee's revisions, streamlining and amendments (or lack thereof) to MAP-21 by a vote of 74-19 (passing the House 373-52) and sent it to the President, who was on the road. He signed a one-week CR, and then penned MAP-21 into law on July 6, 2012. MAP-21 goes into effect on October 1, 2012, sunsetting at September 30, 2104. An added plus is that independent analysis shows that MAP-21 will reduce the federal deficit by \$16 billion over ten years.

Of note to Santa Cruz METRO is that the STIC funding in MAP-21, a merit-based funding program rewarding smaller systems with high performance indicators such as METRO's, has been increased from 1% of total urbanized area funding to 1.5%, an increase estimated to be in the \$500,000 - \$750,000 range. Santa Cruz METRO, along with other STIC recipients in the FTA community, have been advocating strongly for this program since 2011. In the past, Santa Cruz METRO has used this funding for capital projects, though it retains operational fungibility.

Congress passed a six-month Continuing Budget Resolution to save contentious budget discussions until post-election. Republican candidate and presumed nominee Romney chose Rep. Ryan (R-WI) as his running mate. Rep. Ryan is the author of the House budget which includes draconian cuts to public transportation. An analysis of this budget's impact on S anta Cruz METRO, should it be implemented, would result in the agency's reduction to a skeletal 30-40 bus system with limited service along major corridors only, with an aging fleet lacking adequate funding for timely replacement.

The Senate Finance Committee passed a "Tax Extenders" package including the alternative fuel tax credit worth up to \$750,000 annually to Santa Cruz METRO, as the CNG fleet continues to grow. It may be heard on the Senate floor following the August recess. Please see **Attachments**

A and B for all federal legislation and issues being monitored, including running mates and the federal budget.

On August 22nd, the California Transportation Commission (CTC) will consider and hopefully approve \$5.812 million in Proposition 1B State and Local Partnership Program (SLPP) funding to Santa Cruz METRO for the Metro Base projet. The final amount of this allocation is \$12,000 higher than anticipated. The \$5.812 million will be matched 50/50, as per legislative guidelines, with an equal amount in locally generated, transit-dedicated sales tax revenue, supplanted over two (2) fiscal years with State Transportation Assistance (STA) funding (with operational flexibility through 2015). A Board Resolution was approved in June 2012 for the use of SLPP funds for the final phase of the MetroBase project. In addition, State Transit Assistance (STA) revenues for the coming FY13 year are anticipated to be up to \$452,442 higher than anticipated for Santa Cruz METRO. Staff will continue to monitor.

The news has not changed that the State's revenue predictions this year have been rosier than reality. Budget-related ballot measures are critical to the State's budget going forward, but may be overshadowed by an overloaded ballot, confusing voters with "ballot fatigue," who then are more likely to vote "no" on everything spending-related, particularly in this political climate. If these measures do not pass, serious and potentially unrecoverable cuts to social service programs and education will occur, and deeper cuts may eventually trickle down to transportation and transit once again.

Cap-and-Trade is another hot-button issue and amendments to the Budget Act (SB 1018) have been proposed which support the positions of the California Transit Association (CTA) and other many local and regional government entities in advocating for the California Air Resources Board (CARB) to specifically allocate auction revenues of carbon credits to fund the mandates of AB 32, the "Greenhouse Gas Law." The implementing legislation, SB 375, requires a funding mechanism be created and Cap-and-Trade is an ideal source of revenue to meet the planning goals that sustainable communities' strategies require statewide. Ongoing advocacy via letters, calls and visits to legislators to ensure that the transportation sector is on the receiving end of auction revenues from carbon credits are encouraged.

AB 1706, r egarding bus axle weight, has been significantly changed due to push-back and compromise with cities, counties and other entities concerned with the pavement impacts of heavy buses. The proposed legislation now "grandfathers" in all rolling stock purchased before 12/31/12 with the caveat that future buses purchased between 2013-2015 be of a similar or lesser weight. It also encourages bus manufacturers to make leaner, greener equipment and basically buys two additional years to come up with a real solution. It passed the Senate Appropriations Committee on 8/6/12.

Cruz METRO is also monitoring the Governor's proposal to create a single transportation agency (in part in anticipated response to the FTA's streamlining of programs in MAP-21). **Please see Attachments C and D**.

IV. FINANCIAL CONSIDERATIONS

As most potential legislation carries a fiscal impact, staff will report on a monthly basis of newly implemented federal and/or State legislation which financially impacts Santa Cruz METRO.

MAP-21 will result in approximately \$5.73 million in formula funding in FY13 (STIC funds = \sim \$1.65 million of this amount) and approximately \$5.82 million in formula funding in FY14 (STIC funds = \sim \$1.68 millon of this amount). In addition, Santa Cruz METRO is slated to receive formula Bus and Bus Facilities funding in the amounts of \sim \$561,000 in FY13 and \sim \$588,000 in FY14. More specific information will be available in later reports. Finally, this does not represent any funding available in the few remaining, discretionary, competitive grant programs in MAP-21.

At the state level, Santa Cruz METRO anticipates an allocation of \$5.812 m illion in SLPP funding on A ugust 22, 2012. The agency also anticipates increased State Transit Assistance revenue of \$452,442 in FY13. In regard to the state budget, much will depend on who holds the majority on the second Wednesday in November. It would be impossible and irresponsible to speculate at this time what state budget considerations may end up being.

Federal Legislative Issues and Status Report August 16, 2012

Current Legislative Issues

Long Term Surface Transportation Act—Conference Bill HR 4348, aka MAP-21

Update at 8/16/12: At last report, it was uncertain that a transportation bill could pass, and almost guaranteed that a tenth Continuing Resolution of SAFETEA-LU was in the works. It was, but only for a week. On June 29, 2012, the Senate had approved the Conference Committee's revisions, streamlining and amendments (or lack thereof) to MAP-21 by a vote of 74-19 (passing the House 373-52) and sent it to the President, who was on the road. He signed a one-week CR, and then penned MAP-21 into law on July 6, 2012.

MAP-21 goes into effect on October 1, 2012, sunsetting at June 30, 2104. The many program consolidation impacts on California are discussed in general in the attached documents, and the overall impacts to existing programs can be seen in the comparative budgets of MAP-21 versus SAFETEA-LU. The FTA is currently in the process of conducting webinars and distributing materials on the new legislation, as well as having created a MAP-21-specific website outlining all programs and changes to existing law. An added plus is that independent analysis shows that MAP-21 will reduce the federal deficit by \$16 billion over ten years.

Small Transit Intensive Cities (STIC) Funding in MAP-21

Update at 8/6/12: Of note to Santa Cruz METRO is that the STIC funding in MAP-21, a meritbased funding program rewarding smaller systems with high performance indicators such as METRO's, has been increased from 1% of total urbanized area funding to 1.5%, an increase estimated to be in the \$500,000 range for our community, possibly more. Santa Cruz METRO, along with other STIC recipients in the FTA community, have been advocating strongly for this program since 2011. Thanks go to Carolyn Chaney and her staff at Capital Edge for doggedly monitoring this program over all the years it has been in place and to General Manager Les White for his role in creating this funding tier in SAFETEA-LU in the first place. In this political climate, it is no small victory that it survived the sausage-making. Much was cut from the transportation legislation, thus it is good news to report that STIC funding has actually increased. In the past, Santa Cruz METRO has used this funding for capital projects, though it retains operational fungibility.

FY13 Federal Budget

<u>Updates at 6/13/13 and 8/16/12:</u> Prior to adjourning for August Recess, Congress passed a sixmonth Continuing Resolution on the federal budget, in order to avoid budget showdowns prior to the November election, and a lame-duck session yet to be determined. Spending bills were being passed one at a time, and some were appropriated at less than authorized levels, showing the impact of HR 5, which staff has been monitoring since January. Some appropriations may face Presidential veto. A full budget bottom line remains to be determined. Most important at the time of this report is the imminent nomination and selection of Rep. Ryan (R-WI), the author of the House budget, as Republican Presidential candidate Mitt Romney's vice-presidential running

mate. An analysis of this budget's impact on Santa Cruz METRO, should it be implemented, would result in the agency's reduction to a skeletal 30-40 bus system with limited service along major corridors only, with an aging fleet lacking adequate funding for timely replacement.

Update at 5/18/12: Speaker Boehner has threatened the White House with further cuts in exchange for the upcoming debt-ceiling vote. On 3/23/12, Rep. Ryan (R-WI) introduced the "Path to Prosperity" \$2.8 trillion FY13 budget (HCR 112), which has passed in the House, and would result in for draconian cuts to many programs, including transit. The Senate's FY13 budget (SCR 39) comes in at \$3.1 trillion. Budgets had to be introduced by April 15th, 2012. In February, the President released his \$3.8 trillion proposal, including cuts to defense and tax loopholes and rates on the richest Americans. The President's budget is seen as reelection campaign material.

<u>The NAT GAS (New Alternative Transportation to Give Americans Solutions) Act</u> (HR 1380 and S 1863) and Senate "Tax Extenders Package"

Update at 6/13/12 and 8/16/12: Technically, the above bills are most likely DOA, but the Senate recently passed a Tax Extenders package out of the Finance Committee and then went on August break. The package includes the 50-cent per gallon-equivalent tax credit for alternative fuels (i.e. CNG), retroactive to 1/1/12 and good through 12/31/13. It may be taken up again in September and passed to the House, or continued until the election is over. Staff and contacts in Washington will monitor this tax credit, eventually worth an estimated \$750,000 per year to METRO as more CNG-fueled buses are added to the fleet.

Also of note is that in early May, the Obama administration tightened regulations on hydraulic fracturing ("fracking"), requiring the disclosure of the ingredients in "fracking fluids" injected into the Earth in the mining process when on federal or American Indian lands. Ingredients can include, but are not limited to: sulfuric acid, benzene and instant coffee.

House Resolution 5 (HR 5)

<u>Update at 6/13/12 and 8/16/12</u>: See above under the update to the budget for an example of the impact of HR 5. Staff is continuing to monitor, as this may result in many appropriations bills being vetoed if they pass the Senate and actually make it to the White House in an election year.

<u>Update at 5/18/12</u>: How funds are appropriated will indicate the impact of HR 5. So far, transit appropriations for our area are up. However, an authorization recently made for transportation was cut approximately \$4 billion when appropriated, thus illustrating the overhanging threat.

<u>Update at 1/18/12</u>: In a secret caucus held on January 4^{th,} House GOP members held an unrecorded vote on a proposed Rules package. Passed in this package was HR 5, a separation of the authorization and appropriations processes in regard to infrastructure funding.

Moving Forward with MAP-21 August 8, 2012

The new federal Surface Transportation Act, known as "Moving Ahead for Progress in the 21st Century" or MAP-21 was signed in to law on July 6, 2012. Prior to this overhaul of federal surface transportation laws, the last major changes at the federal level occurred with the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA, pronounced Ice-Tea), more than 20 years ago. Given the major changes inherent in MAP-21, a measured approach to implementation is in order. A measured approach will also allow time to receive additional guidance from the Federal Department of Transportation. The bullets below detail the highlights of the Administration's proposal for MAP-21.

- Funding levels remain the same as Federal Fiscal Year 2012 at \$3.5 billion.
- The Administration's proposal focuses on maintaining a status quo funding level for overall funding ensuring that the State and Local Agencies each receive a total share of funding consistent with total funding received under prior federal acts.
- One cannot view each program in isolation because of the dramatic restructuring of programs and funding included in MAP-21. Many programs were eliminated or combined, and new programs were created. The significant changes to programs and program eligibility add to the challenge of creating a funding plan that maintains current total funding levels.
- The proposal retains the existing funding splits between the State and the Locals/Regions approximately \$2.2 Billion State (62%), approximately \$1.3 billion for Locals/Regions (38%). Changes in this split in the next two years could result in projects that are almost ready to go to construction being removed from the program due to lack of funding.
- Allows for a transitional period recognizing that the regions and the State already have projects programmed against these funds under existing rules:
 - Continues the current level of RSTP funding.
 - Continues the current level of SHOPP program.
 - Continues the current level of Bridge funding for both state and local bridges. The program would continue to be administered by the state.
 - o Continues the flow of CMAQ and MP apportionments to regions using existing formulas.
 - \circ $\;$ Divides the HSIP program as required in MAP-21 after setting aside funds for SRTS.
 - Continues the Safe Routes to School program which would remain administered by the state.
 - Transportation Alternatives Program funding would continue under the STIP formula after setting aside \$5 million for Recreational Trails.
- Legislative changes are not necessary to allow apportionment of funds within California, provided that the state pursues a "status quo" approach discussed above.
- MAP-21 includes and inflation increased to apportionments for FFY 2014. Increases will be applied to programs and all splits.
- Working groups are being established to discuss potential program changes that will take into account federal guidance and performance measurements for MAP-21. The intention is to have a first draft of proposed legislation in early 2013. There will need to be a transition period to implement any program changes.

State of California Legislative Issues and Status Report <u>August 16, 2012</u>

FY12 State Budget and Proposition 1B Bond Programs

Update at 6/13/12 and 8/16/12: On August 23rd, staff will attend the California Transportation Commission (CTC) meeting in Sacramento for the consideration and anticipated approval of \$5.812 million in Proposition 1B State and Local Partnership Program (SLPP) funding to Santa Cruz METRO. The final amount of this allocation is \$12,000 higher than anticipated. The \$5.812 million will be matched 50/50, as per legislative guidelines, with an equal amount in locally generated, transit-dedicated sales tax revenue, supplanted over two (2) fiscal years with State Transportation Assistance (STA) funding (with operational flexibility through 2015) so that both the Operations and Capital budgets remain the same, and all is within the rules for the use of each funding stream. A Board Resolution was approved in June 2012 for the use of SLPP funds for the final phase of the MetroBase project.

State Transit Assistance (STA) revenues for the coming FY13 year are anticipated to be up to \$452,442 higher than anticipated for Santa Cruz METRO. Staff will continue to monitor.

Headlines continue to show that other revenue predictions earlier this year were unfortunately, much rosier than reality. The Governor's budget-related ballot measures are critical to the State's budget going forward. If they do not pass, serious and potentially unrecoverable cuts to social service programs and education will occur, and deeper cuts may eventually trickle down to transportation and transit once again.

Governor's Proposal to Create a Single Transportation Agency

Update at 6/13/12 and 8/16/12: Staff is continuing to monitor this issue, which will be impacted by the post-election State budget, among many other variables. This is a priority of the Governor's and favors a scaled-back number of transportation programs and monitoring agencies and offices. Now that we have a federal surface transportation act, the State Department of Transportation (Caltrans) can more accurately determine the impact of MAP-21 on proposed changes and streamlining measures.

<u>Update at 1/18/12:</u> Governor Brown is proposing a single agency comprised of: Caltrans, the Department of Motor Vehicles (DMV), High Speed Rail Authority (HSRA), California Highway Patrol (CHP), California Transportation Commission (CTC) and the Board of Pilot Commissioners (as in pilot boats). The reasoning is to provide additional oversight, particularly to the HSRA and CTC. The California Transit Association (CTA) is monitoring.

California Air Resources' Board Cap and Trade Program (AB32-mandated)

Update at 6/13/12 and 8/16/12: This is a hot-button issue and amendments to the Budget Act (SB 1018) have been proposed which support CTA, the California Alliance for Jobs, Transportation California and many local and regional government entities in advocating for the California Air Resources Board (CARB) to specifically allocate auction revenues of carbon credits to fund the mandates of AB 32, the "Greenhouse Gas Law." The implementing legislation, SB 375, requires a funding mechanism be created and cap-and-trade is thought to be a good source of revenue to meet the planning goals of sustainable communities' strategies required statewide. Ongoing advocacy via letters, calls and visits to legislators to ensure that the transportation sector is on the receiving end of auction revenues from carbon credits (~66 million of which will be sold at between \$10-\$50 ea.).

The Governor's budget incorporates \$1 billion in expected revenue from the new Cap and Trade regulation under greenhouse gas legislation AB32, which was adopted by the California Air Resources Board in late 2011.

The California Legislature: Bills of Interest

Update at 6/13/12 and 8/16/12: Since last month, all bills with any "legs" moved from the House of origin to the next. AB 1706, the legislation regarding bus axle weight, has been significantly changed due to push-back and compromise with cities, counties and other entities concerned with pavement impacts heavy buses (and potential revenue generated from some sort of usage fee or penalty), and now grandfathers in all buses purchased before 12/31/12 with the caveat that future buses purchased between 2013-2015 be of a similar or lesser weight, encourages bus manufacturers to make leaner, greener equipment and basically buys two additional years to come up with a real solution among stakeholders. Since the Governor does not like "blue-ribbon panels," this idea has been gutted from the bill. It passed the Senate Appropriations Committee on 8/6/12 after much in the way of advocacy efforts from the CTA.

See above for information on SB 1018, the Budget Act.

Update at 4/18/12 and 5/18/12: Letters to all members of the Assembly Transportation Committee were faxed in support of AB 1706 (D-Eng). Santa Cruz METRO is also monitoring AB 1532 (D-Perez), the so-called "Speaker's Bill" and AB 2404, to collect and distribute fees for purposes of carrying out AB 32. See **Attachment D.**

Statewide Eliminiation/Liquidation of Redevelopment Agencies (RDAs)

Update at 6/13/12 and 8/16/12: This unpleasant process continues, with the State Director of Finance rejecting all appeals requesting any sort of exemption regarding former RDA funds. It is still messy and complicated. Continuing to monitor. (California RDAs lost a decision at the State Supreme Court level and are now required to dissolve.) Money goes to the state and will redistributed to the schools.

SUBJECT: CONSIDERATION OF IMPLEMENTING A REGULATION ENTITLED HEALTHY FOOD AND BEVERAGE OPTIONS AT SANTA CRUZ METRO FACILITIES

I. RECOMMENDED ACTION

Adopt the attached Regulation entitled Healthy Food and Beverage Options at Santa Cruz METRO Facilities

II. SUMMARY OF ISSUES

- At the February 24, 2012, Santa Cruz METRO Board of Directors regular meeting, Vice Chair Daniel Dodge facilitated a presentation by the Jovenes Sanos Group on healthy vending food choices for the Watsonville Transit Center Tenants. The group presented a video to raise awareness of Childhood Obesity and Diabetes and how Santa Cruz METRO could make a contribution through its policy decisions regarding the food products in its vending machines or sold by its vendors at the transit centers.
- Director Dodge indicated that he would support more healthy selections in vending machines at Santa Cruz METRO's transit centers. At the conclusion of the Jovenes Sanos Group presentation, the Board of Directors created a Task Force to review policies regarding this matter and make recommendations.
- On May 11, 2012, the Santa Cruz METRO Board of Directors discussed the concept of implementing a healthy food and beverage policy for Santa Cruz METRO employees' vending machines and for transit center food/beverage restaurants and kiosks.

III. DISCUSSION

The Healthy Options Task Force met to discuss how best to implement a program which would have a real impact on Santa Cruz METRO's transit center food and beverage options as well as the vending machines located in Santa Cruz METRO facilities. The Task Force was sensitive to the needs of the transit center tenants not wanting to take any actions which would jeopardize the viability of the businesses. The Task Force wanted to help the tenants improve their business products with more healthy options.

The Task Force also discussed modifications to the vending machine products. The proposed policy set forth in Attachment A incorporates many of the proposals submitted by the Task Force for vending machines.

The Task Force recognized that an important component to a Healthy Food and Beverage Options Program is education. The proposed regulation incorporates a requirement for annual distribution of written materials and information to Santa Cruz METRO employees and tenants regarding the impacts of obesity on the individual and society and how to maintain a healthy weight.

Santa Cruz METRO operates its transit services by and through four (4) transit centers located throughout Santa Cruz County: Pacific Station in downtown Santa Cruz, 920 Pacific Avenue, Santa Cruz, CA. 95060, Watsonville Transit Center, 475 Rodriguez Street, Watsonville, CA 95076, Bart Cavallero Transit Center, 246 Kings Village Drive, Scotts Valley, CA 95066, and Capitola Mall, 1855 41st Avenue, Capitola, CA 95010.

Santa Cruz METRO leases space at the transit centers to small businesses in order to provide various food and beverage options for Santa Cruz METRO passengers and the public. The location, business name and type of food presented are as follows:

Further, Santa Cruz METRO has the majority of its employees working in four other locations: Administration Offices, 110 Vernon Street, Santa Cruz, CA 95060, Maintenance Facility, 138 Gulf Club Drive, Santa Cruz, Ca 95060, Operations Facility 1200 River Street, Santa Cruz, CA 95060, and ParaCruz Administration and Operations, 2880 Research Park Drive #160, Santa Cruz, CA, Soquel, CA. Each of these buildings contains vending machines which employees access on a regular basis. As of May 11, 2012, the vending machines at these facilities contained snack items and drinks, as listed below:

I. POLICY

- 1.01 The Santa Cruz Metropolitan Transit District (Santa Cruz METRO) recognizes that obesity is a significant health issue in the County of Santa Cruz and has an impact on Santa Cruz METRO's annual budgets through higher costs for health insurances and on the provision of public transportation.
- 1.02 Santa Cruz METRO finds that promoting healthy food and beverage options at its facilities including its transit centers, is an effective way to reduce health issues related to unhealthy eating habits such as diabetes, heart disease, and being overweight.
- 1.03 Santa Cruz METRO designed this regulation to encourage its employees to eat in a more healthy way and to encourage the transit center tenants/vendors to offer healthy food and beverage options as an effective way to provide its passengers and the public with healthy alternatives.
- 1.04 Santa Cruz METRO requires that all vending machines made available to its employees on Santa Cruz METRO premises have healthy options included in the items for sale as specifically set forth within this regulation.
- 1.05 Santa Cruz METRO recognizes that it must lead by example in order to have its employees, vendors and customers follow suit and, therefore, commits itself to the practice of healthy eating by offering healthy options in all Santa Cruz METRO sponsored programs and events.

II. APPLICABILITY

- 2.01 This regulation is applicable to Santa Cruz METRO employees, transit center tenants/vendors and vending machine operators.
- 2.02 The applicable contents of this regulation shall be implemented by Santa Cruz METRO's Purchasing Agent or his/her designee in the installation, operation and maintenance of all

vending machines in Santa Cruz METRO facilities which are accessed by Santa Cruz METRO's employees.

- 2.03 The applicable contents of this regulation shall be implemented by Santa Cruz METRO's District Counsel in the letting of tenant space.
- 2.04 The Administrative Services Coordinator and/or his/her designee is required to insure that at each and every Santa Cruz METRO sponsored program or event at which food is offered that healthy food options are made available.

III. DEFINITIONS:

- 3.01 Healthy Beverage Option: See Section 4.01a below.
- 3.02 Healthy Food Option: See Section 4.01a below.
- 3.03 Obesity: Obesity is a chronic condition defined by an excess amount body fat.
- 3.04 Santa Cruz METRO sponsored program and/or event: A Santa Cruz METRO program/event in which Santa Cruz METRO provides at least 50% of the food.

IV. STANDARDS:

- 4.01 The following standard for all vending machines located in any Santa Cruz METRO facility shall be implemented through the Purchasing Agent and/or his/her designee as follows:
 - a. Fifty Percent of the Beverages in each vending machine shall be limited to the following criteria:
 - i.) Water;
 - ii.) Coconut water;
 - iii.) 100% fruit/vegetable juice;
 - iv.) Fruit-based drinks containing at least 50% juice and no added caloric sweeteners;
 - v.) All other non-caloric beverages, including diet sodas;
 - vi.) Sports drinks less than or equal to 100 calories; and
 - vii.) No greater than 12 ounces except water, with a preference for juices in small size portions (6 ounces).
 - b. Fifty percent of Snacks/foods shall meet all the following criteria per individual package;
 - i.) Not more than 250 calories;

- ii.) Not more than 35% calories from fat with the exception of nuts and seeds, snack mixes and other foods of which nuts are a part must meet the 35% standard;
- iii.) Not more than 10% calories from saturated fat;
- iv.) Does not contain trans fats added during processing (hydrogenated oils and partially hydrogenated oils);
- v.) Not more than 35% total weight from sugar and caloric sweeteners with the exception of fruits and vegetables that have not been processed with added sweeteners or fats; and
- vi.) Not more than 360 mg of sodium per serving.
- c. At least one item meeting the snack criteria in each vending machine shall also meet the FDA definition of "low sodium" (less than 140 mg per serving).
- d. The vending machine options shall contain some items that include at least 2 grams of dietary fiber.
- e. Items that meet nutrition standards shall not be priced higher than the items that do not meet the standards.
- f. Advertising on vending machines shall include advertising only of beverages and foods that meet the nutrition standards.
- 4.02 The following standard for all beverage/ food vendors-tenants at Santa Cruz METRO transit centers shall be implemented through the terms as conditions of the Lease Agreements as follows:
 - a. Santa Cruz METRO tenants are encouraged to provide healthy food and beverage options at their establishments.
 - b. Santa Cruz METRO tenants are encouraged to participate in the Healthy Food and Beverage Options Program which is set forth in Attachment A
- 4.03 The following healthy food and beverage option standard shall be implemented by the Administrator Services Coordinator at all Santa Cruz METRO sponsored events and programs:
 - a. The criteria set forth in Section 4.01 regarding Vending Machines shall be implemented at all Santa Cruz METRO sponsored events and programs.
- 4.04 On an annual basis, the Human Resources Manager or his/her designee shall distribute to all employees written materials on the dangers of obesity, how to maintain a healthy weight and what healthy food and drink options are available in the local markets. Similar written materials shall be provided to all Santa Cruz METRO tenants on an annual basis by the District Counsel.

V. ADMINISTRATION OF REGULATION

- 5.01 The Purchasing Agent or his/her designee shall insure that all contracts with vending machine companies comply with this policy. District Counsel will insure that all Santa Cruz METRO leases contain language that encourages the tenants to provide healthy food and beverage options on their menus or as products in their stores.
- 5.02 Santa Cruz METRO will integrate the Healthy Food and Beverage Options at Santa Cruz METRO Facilities Policy into their Policies and Procedures.
- 5.03 The Human Resources Manager or his/her designee shall provide a copy of this policy to all new employees and to any other employee upon request.

Attachment A

Santa Cruz METRO's Healthy Food and Beverage Options Program

- 1. Santa Cruz METRO encourages each transit center Tenant to provide healthy food and beverage options for sale at its business.
- 2. Additionally, Santa Cruz METRO establishes the Santa Cruz METRO's Healthy Food and Beverage Options Program in order to further encourage its Tenants to offer healthy food and beverage alternatives to its customers. To participate in the program, the Tenant of a food/beverage store or kiosk must be willing to offer at least 10 new healthy products (Criteria set forth in Sections 4.01a. and b. of the Regulation) to its customers for a minimum period of time of 6 months. If the Tenant operates a restaurant, to participate it must be willing to offer at least 3 new healthy menu options (Criteria set forth in Attachment) to customers for a minimum period of time of 6 months. (Notwithstanding the criteria set forth herein, the Tenant must remain in compliance with the terms and conditions of the Lease Agreement.)
- 3. Any Tenant who wishes to participate in the Healthy Food and Beverage Option Program will notify the Santa Cruz METRO's Paralegal who is serving in the capacity of Property Manager. The Tenant will complete an application and return it to the Property Manager.
- 4. Thereafter, the Property Manager and the tenant will meet to review the application and to insure that the new healthy options meet the required criteria and that they are in conformity with the terms and conditions of the Lease Agreement. If all eligibility requirements are met, the Property Manager and the Tenant will create a letter agreement in which the Tenant identifies the various products or menu items which meet the required criteria and which the Tenant agrees to sell on a regular basis at his/her business for the minimum period to qualify for the program.
- 5. During the period of the Agreement, the Property Manager will provide the business with support and encouragement which may include written materials.
- 6. At the conclusion of the 6 month period, the Tenant will provide a signed affidavit attesting to its compliance with the Program criteria. Upon receipt of the affidavit, the Tenant will be invited to attend a meeting of the Santa Cruz METRO Board of Directors to be recognized as a "Santa Cruz METRO Healthy Vendor." All media outlets will be notified of the award and invited to attend the event. Additionally, Santa Cruz METRO will issue a press release which honors the tenant receiving the award.

Attachment A-1

Additional Healthy Food Options

- 1. Fruits or vegetables prepared in a low-fat way (ex. green salads, baked potato, stir fried or steamed vegetables);
- 2. Fruits or vegetables offered as a substitute for less healthy side dishes such as french fries;
- 3. Offer at least one fat free or low fat salad dressing;
- 4. Include skim milk or 1% milk on the menu if milk product is served;
- 5. Offer water and make it accessible to customers free of charge;
- 6. Offer whole grain bread as an option instead of white bread, or a no bread option (lettuce wrap);
- 7. Offer at least one healthier dessert option. (ie: fresh fruit);
- 8. Prepare meat, fish, poultry, or meat alternative in a low fat way such as broiling, baking, poaching, roasting, and steaming or stir frying. Visible fat removed from any meat or poultry before cooking;
- 9. Offer at least one low-fat vegetarian dish (low-fat not exceeding 500 calories);
- 10. Provide option to serve, butter, margarine, sour cream, salad dressing, or mayonnaise on the side or not at all;
- 11. Offer a menu with smaller portions or half portion meals at a lower cost. Allow customer to split a meal at no cost.
- 12. Provide calorie information visible at the point of purchase or provide healthier option stickers on the menu;
- 13. Offer corn tortillas instead of flour tortillas;
- 14. Offer whole beans instead of refried beans.
